MPL BRITISH COLUMBIA DISTRIBUTORS INC. (MPL BC) AGENCY PRIOR APPROVAL PROCESS – HEARING PARTICIPANT DECISION

On April 24, 2023, the BC Farm Industry Review Board (BCFIRB) invited all eligible participants to submit a written application by May 1, 2023 to participate in the forthcoming in-person supervisory hearing.

In the same letter, BCFIRB confirmed that the BC Vegetable Marketing Commission (Commission) as first instance regulator, and MPL BC, as the agency applicant, are granted full participatory rights at the in-person supervisory hearing. BCFIRB also granted Greenhouse Grown Foods Inc./Windset farms (Canada) Ltd. (GGFI/Windset) full participatory rights, including the opportunity to call witnesses and question those participants adverse in interest.

Subsequently, BCFIRB received process requests from MPL BC and GGFI/Windset. These requests will be addressed in separate correspondence.
