#### Amendment

WHEREAS the Licensee is the holder of Tree Farm Licence Number 44.

And whereas the Ministry of Forests and the Licensee of said Tree Farm Licence Number 44 have entered into a land exchange that is mutually agreeable to both parties namely "The Alberni Airport Land Exchange."

And whereas the Licensee has requested both the withdrawal of the aforementioned lands as described in Appendix "A" attached and the addition of the aforementioned lands as described in Appendices "B" and "C" attached;

Therefore pursuant to Section 33.1 of the Forest Act, the following lands are herewith withdrawn from Schedule "A" of the said Tree Farm Licence; namely that land as described on the attached Appendix "A" being more particularly shown outlined in bold black on the plan attached, and the said lands so withdrawn are and shall be hence forth no longer part of or subject to the said Tree Farm Licence Number 44;

The following lands are herewith added to the lands described in Schedule "A" of said Tree Farm Licence; namely that land as described on the attached Appendix "B" and said lands so added are and shall be henceforth part of and subject to the said Tree Farm Licence Number 44 and;

The following lands are herewith added to the lands described in Schedule "B" of the said Tree Farm Licence Number 44; namely, that land as described in Appendix "C" attached hereto, being more particularly shown outlined in bold black on the Exhibit 'A' attached hereto, and the said lands so added are and shall be henceforth part of and subject to the said Tree Farm Licence Number 44.



## INSTRUMENT NO. 6 TO T.F.L. 44

Commencing at the northeast corner of Lot 5, Barclay Land District; thence westerly along the northerly boundaries of said Lot 5, and Lot 1961, Clayoquot Land District to the southeasterly boundary of Lot 356; thence northeasterly, northwesterly and southwesterly along the southeasterly, northeasterly and northwesterly boundaries of said Lot 356 to the natural boundary of Uchucklesit Inlet on the northeasterly shore thereof; thence in a general northwesterly direction along the natural boundary of said Uchucklesit Inlet on the northeasterly shore thereof to the southeasterly boundary of Lot 331; thence northeasterly, northwesterly and southwesterly along the southeasterly, northeasterly and northwesterly boundaries of said Lot 331 to the natural boundary of aforesaid Uchucklesit Inlet on the northeasterly shore thereof; thence in a general northwesterly direction along the natural boundary of said Uchucklesit Inlet on the northeasterly shore thereof to the southeasterly boundary of Lot 334; thence northeasterly and northwesterly along the southeasterly and northeasterly

boundaries of said Lot 334 to the southeasterly boundary of Lot 336; thence northeasterly along the southeasterly boundaries of Lots 336 and 337 to the southeast corner of said Lot 337; thence northwesterly along the northeasterly boundary of said Lot 337 to the northeast corner thereof; thence south 60 degrees east 780 metres; thence south 100 metres; thence south 48 degrees east 600 metres; thence east 550 metres; thence south 450 metres; thence east 390 metres; thence south 230 metres, more or less, to the most northerly corner of Lot 96 Alberni Land District; thence southwesterly along northwesterly boundary of said Lot 96, to the northeasterly boundary of Lot 44; thence northwesterly, southwesterly and southeasterly along the northeasterly, northwesterly and southwesterly boundaries of said Lot 44 to the northerly boundary of Lot 598, Clayoquot Land District; thence westerly along the northerly boundaries of Lots 598, 597 and 596 to the easterly boundary of aforesaid Lot 5, Barclay Land District; thence northerly along the easterly boundary of said Lot 5 to the northeast corner thereof, being the point of commencement.
