INTRODUCTION OF BILL 35—THE PHARMACEUTICAL SERVICES ACT



On Tuesday, April 24, 2012, the provincial government introduced Bill 35, the Pharmaceutical Services Act, which provides supporting legislation for the \$1-billion PharmaCare program.

NOW AVAILABLE—HPV VACCINE GUIDE FOR PHARMACISTS

HPV Vaccine (Cervarix[™]) One-Time Program for Young Women Born 1991, 1992, or 1993

Starting in mid-April 2012, BC launched a time-limited program of publicly funded HPV vaccination (Cervarix[™]) for young women who were born in 1991, 1992, or 1993.

Pharmacists authorized to administer immunizations can access this vaccine and administer it to eligible BC residents.

VANCOUVER COASTAL HEALTH: PERTUSSIS IMMUNIZATION INFORMATION FOR PHARMACISTS NOW AVAILABLE ONLINE

Vancouver Coastal Health recently expanded the eligibility criteria for people to receive free pertussis-containing vaccine (TDaP - Adacel[®]). Pharmacists authorized to administer immunizations who work in pharmacies located in the Vancouver Coastal Health Authority are invited to order and administer vaccine to eligible BC residents. This invitation is similar to the one extended to pharmacists in the Fraser Health Authority last month

Details about the program, including patient eligibility, how to obtain vaccine, and billing procedures, were e-mailed to authorized pharmacists on March 23, 2012, and are now available on the Vancouver Coastal Health Authority website at <u>www.vch.ca/your health/health-</u> <u>topics/communicable diseases/for health professional</u> s/for-pharmacists.



FREQUENCY OF DISPENSING

As outlined in the <u>PharmaCare Policy Manual</u>, fee limits are per pharmacy. If a patient fills prescriptions at more than one pharmacy on the same day, each pharmacy can claim the maximum number of fees allowed under the policy.

However, dividing patient claims between two or more pharmacies in order to circumvent the maximum number of fees covered under the Frequency of Dispensing Policy is not permitted and is subject to audit by the Ministry of Health.

ELIGIBILITY CHANGE FOR MEDICATION REVIEW SERVICES

Funding to support expanded patient access to medication review services is in place for this year.

Effective **May 1, 2012**, a patient with five medications (i.e., any prescription medication, non-prescription drug product, compounded drug product, and/or injection that has a DIN or PIN) that have been entered into PharmaNet within the last six months is eligible. Previously, patients were required to have seven such medications.

The **Medication Review Services—Policies, Guidelines and Procedures for Pharmacists** manual and adjudication procedures will be updated soon to reflect this change.

Special Authority Coverage of Hydromorphone Prolonged Release (Jurnista®)

Effective March 30, 2012, hydromorphone prolonged release (Jurnista[®]) became available as a Limited Coverage benefit through PharmaCare's Special Authority (SA) program for pain management in a specified chronic pain (including cancer pain) diagnosis. Detailed criteria are available on the PharmaCare website at www.health.gov.bc.ca/pharmacare/sa/criteria/restricted/hydromorphone.html.

Coverage of hydromorphone prolonged release is subject to the usual rules of a patient's BC PharmaCare plan, including any deductible requirement. Retroactive coverage cannot be provided for prescriptions filled before SA approval is in place.
