2009 Carbon Neutral Action Report

Executive Summary

2009 was the first year the Industry Training Authority (ITA) participated in a carbon neutral program. Our annual reporting will be based on the calendar year.

The ITA, consisting of approximately 52 staff does not have a vehicle fleet. We maintain two office locations, which are leased through ARES. One of the main criteria in selecting our Vancouver location was its proximity to public transportation, which we hoped would reduce the number of staff and clients needing to drive to our location.

Also of note, in partnership with Industry Training Organizations (ITOs), the ITA is supporting emerging opportunities in the green technology sector such as the Geo Thermal Technician. The majority of ITA's carbon neutral initiatives focus is in four areas:

- Reducing Travel (including use of personal vehicles) by increasing the use of video and audio conferencing capabilities;
- Purchasing 100% recycled paper;
- Implementing strategies to reduce the carbon footprint of computer technology;
- Work with ARES to explore options to reduce emissions within a leased space.

Actions Taken to Reduce Greenhouse Gas Emissions in 2009

Significant actions in 2009 include migration to a new IT infrastructure utilizing VM servers, a blade centre and the initial implementation of the ITADirectAccess project, which, when complete will provide electronic access for apprentices, sponsors, training providers, school districts and the ITOs. In 2009/10 access was made available to ITA staff and training providers.

Plans to Continue Reducing Greenhouse Gas Emissions 2010 – 2012

2010/11 will see the continued rollout of ITADirectAccess (Release 2) to apprentices, sponsors, ITOs and school districts. Electronic access will support online apprentice registrations and work-based hours reporting as well as email communication and the upload of marks from training providers. The system will also reduce the need for the submission of paper documents, reduce the number of mail outs, and reduce the number of people travelling to the ITA's office for customer service.
