

# INSTRUCTIONS FOR COMPLETING THE APPLICATION FOR REFUND OF PROVINCIAL SALES TAX – FOSSIL FUEL COMBUSTION SYSTEM OR HEAT PUMP

under the Provincial Sales Tax Act

#### **GENERAL INFORMATION**

Complete this form to claim a refund of provincial sales tax (PST) paid on a fossil fuel combustion system or heat pump. For definitions and additional information on eligibility, refer to **Notice 2022-003**, Provincial Sales Tax on Fossil Fuel Combustion Systems and Heat Pumps.

Follow the instructions carefully as your application will be returned to you for revision if:

- · the form is incomplete, or
- the required documents are not provided (refer to Part D of the application and the Checklist of Requirements on Page 4 for details).

An application for refund of PST paid on fossil fuel combustion system(s) must be received by the ministry within four years from the date you paid the PST.

An application for refund of PST on heat pumps must be received by the ministry **on or before April 1, 2026.** 

#### WHO SHOULD USE THIS FORM?

- 1. Contractors applying for a refund of 5% PST paid on the purchase price of a fossil fuel combustion system if:
- you have purchased or received, or sent or brought the system(s) into B.C., on or after April 1, 2022,
- you have a written agreement with your customer dated before February 23, 2022 to affix or install the system(s), and
- you paid 12% PST on the purchase price of the system(s).
- 2. Contractors applying for a refund of 7% PST paid on the purchase price of a heat pump if:
- you purchased or received, or sent or brought the heat pump(s) into B.C., before April 1, 2022, and
- you affixed or installed the heat pump(s) on or after April 1, 2022.
- 3. Customers applying for a refund of 5% PST paid on the purchase price of a fossil fuel combustion system if:
- you have an agreement with your contractor that you pay the PST,
- you have a written agreement with your contractor dated before February 23, 2022 to affix or install the system(s),

- your contractor purchased or received, or sent or brought the system(s) into B.C., on or after April 1, 2022, and
- you paid 12% PST on the purchase price of the system(s).
- 4. Customers applying for a refund of 7% PST paid on the purchase price of a heat pump if:
- you have an agreement with your contractor that you pay the PST,
- your contractor purchased or received, or sent or brought the heat pump(s) into B.C., before April 1, 2022, and
- your contractor affixed or installed the heat pump(s) on or after April 1, 2022.

**Note:** Contractors cannot claim a refund if the agreement states your customer will pay the PST.

#### **COMPLETING YOUR APPLICATION**

### Part A – Applicant Information

#### Item 1

Enter the full current legal name of the applicant who paid the tax. An operating name or "doing business as" name may not be the legal name. If the applicant is a corporation, enter the name as it appears on the incorporation certificate. If the applicant is a proprietorship, the legal name is the legal name of the individual who owns the business.

#### Item 2

Enter your nine-digit business number (BN) provided by Canada Revenue Agency, if you have one.

#### Item 3

If you are a registered collector under the Provincial Sales Tax Act, enter your PST number.

#### Item 4

Enter your complete mailing address. Where applicable, a cheque and/or a refund decision letter will be mailed to this address. This address should not be the address of a third-party representative, such as an external accountant, bookkeeper or consultant.

#### Item 5

Enter the name and telephone number of a person to contact if the ministry has questions about your application.

#### Part D - Reason for Refund

#### Item 6

Indicate your reason(s) for claiming a refund by checking all boxes that apply in the Reason for Refund column. For additional details on eligibility, refer to Notice 2022-003, Provincial Sales Tax on Fossil Fuel Combustion Systems and Heat Pumps.

#### Item 7

For each contract, attach all required documents. See explanation of document numbers on Page 5.

#### Item 8

Provide a written statement certifying why you are entitled to a refund of PST.

# Part E – Refund Claim Schedule Item 9

Each application must include a detailed listing of each contract for which you are claiming a refund. If you require more space, use either:

- the Refund Claim Schedule in Excel, available on the ministry website, or
- · a schedule that includes all the required details.

For each contract, identify:

- · the contract date,
- · your role as either a contractor or customer,
- the date the contractor purchased or received, or sent or brought the system(s) or heat pump(s) into B.C., and
- the total PST you paid on systems or heat pumps for each contract.
- Line 1 Enter fossil fuel combustion system(s) or heat pump(s) at the top of each column as needed. If a contract includes affixing or installing both systems and heat pumps, enter the information in different columns.
- Line 2 Enter the contract date.
- **Line 3** Enter your role in the transaction (contractor or customer).
- Line 4 Enter the date you (if you are a contractor) or your contractor (if you are a customer) purchased or received, or sent or brought the system(s) or heat pumps into B.C.
- **Line 5** Enter the total PST paid on the system(s) or heat pump(s) for the contract.
- **Line 6** Enter the rate used to calculate the eligible refund amount. For fossil fuel combustion systems, enter 5/12. For heat pumps, enter 1.0.

- Line 7 Enter the refund amount for the transaction by multiplying Line 5 by the rate entered in Line 6. For clarity if you are completing the form manually for a fossil fuel combustion system transaction, multiply Line 5 by five and then divide by twelve. For heat pumps, multiply by one.
- Line 8 Enter the total dollar amount of your refund claim in column E. If you do not enter an amount, your application will be returned. The ministry cannot issue a refund of less than \$10

If you complete the form electronically, Lines 6, 7 and 8 are calculated automatically.

## Part F – Applicant Certification Item 10

This application must be signed by the person who paid the tax. If the tax was paid by a corporation or a society, the application must be signed by a director, or by an employee who has been delegated authority to sign on behalf of the corporation or society. You may be required to provide evidence that the person who signed the application has the authority to sign. An application that is not signed, not signed by a signing authority or is signed by a third party (such as an external accountant, bookkeeper or consultant) will be returned.

- 2 A copy of the bill of sale (i.e. a record of the transaction) showing payment, including any tax paid, by the customer to the real property contractor for the fossil fuel combustion system(s) or heat pump(s).
- 3 A copy of a written agreement dated before February 23, 2022, to supply and affix, or install, the fossil fuel combustion system(s). If you are a customer, the written agreement must indicate you have agreed to pay the PST to a real property contractor. For information on qualifying evidence for customers agreeing to pay PST, see Bulletin PST 501, Real Property Contractors.
- 4 If not included in Document 1, documentation showing your purchase of the fossil fuel combustion system(s), or receipt of delivery of the system(s), or the date you sent or brought the system(s) into B.C., was on or after April 1, 2022.
- 5 If not included in Document 1, documentation showing your purchase of the heat pump(s), or receipt of delivery of the heat pump(s), or the date you sent or brought the heat pump(s) into B.C., was before April 1, 2022.

- 6 Documentation (e.g. contractor's proof of purchase) showing the real property contractor's purchase of the fossil fuel combustion system(s), or receipt of delivery, or the date the contractor brought or sent the system(s) into B.C., was on or after April 1, 2022.
- 7 A copy of a written agreement to affix or install the heat pump(s). If you are a customer, the written agreement must indicate you have agreed to pay the PST to a real property contractor. For information on qualifying evidence for customers agreeing to pay PST, see Bulletin PST 501, Real Property Contractors.
- 8 Documentation showing you affixed or installed the heat pump(s) on or after April 1, 2022, or a written statement certifying you affixed or installed the heat pump(s) on or after April 1, 2022.
- 9 Documentation (e.g. contractor's proof of purchase) showing the real property contractor's purchase of the heat pump(s), or receipt of delivery, or the date the contractor brought or sent the heat pump(s) into B.C., was before April 1, 2022.
- 10 Documentation showing the real property contractor affixed or installed the heat pump(s) on or after April 1, 2022, or a written statement from the contractor certifying the real property contractor affixed or installed the heat pump(s) on or after April 1, 2022.
