BETWEEN:

THE MINISTER OF LANDS, FORESTS, AND WATER RESOURCES of the Province of British Columbia, who, with his successors in office, is

hereinafter called "the Licensor",

OF THE ONE PART,

AND:

TAHSIS COMPANY LTD., a corporation duly incorporated under the laws of the Province of British Columbia and having its registered office in the City of Vancouver in the said Province,

hereinafter called "the Licensee",

OF THE OTHER PART.

WHEREAS by an Indenture dated the 23rd day of December 1954, the Licensor did grant unto the Licensee a Tree Farm Licence (hereinafter referred to as "the Tree Farm Licence") which is known and referred to as the "Tahsis Tree Farm Licence" and is numbered nineteen (19) in the Forest Service register of Tree Farm Licences and on the official atlas maps of the Department of Lands, Forests, and Water Resources;

AND WHEREAS the parties hereto mutually agreed to amend the said Indenture as hereinafter set forth;

NOW THEREFORE THIS INDENFURE WITNESSETH THAT in consideration of the premises and mutual agreements hereinafter expressed it is hereby agreed as follows:

(1) THAT the following Clause 10A be added to the said Indenture dated 23rd day of December 1954;

- "Notwithstanding the provisions contained in clauses 8, 9 and 10 if in the opinion of the Licensor it is not necessary to withdraw lands for such other purposes then the Licensor may in his discretion not withdraw such lands but may grant the use of such lands for the said purposes; provided however that before making such grant of use the Licensor notifies the Licensee of the application for the proposed use and in the event the Licensee does not within 30 days object to the same the Licensor may make the grant of use. In the event the Licensee objects to the making of such a grant the Licensee objects to the making of such a grant the Licensee in respect of such use and in the event no agreement is made within 30 days after the objection the Licensor may grant the use of such lands subject to such terms and conditions as he deems advisable."
- (2) THAT subject to the terms of this Agreement the parties hereto confirm in all other respects the said Indenture dated the 23rd day of December 1954 and amendments thereto to the date hereof.
