

# INSTRUCTIONS FOR COMPLETING THE DECLARATION OF AGREEMENT TO PAY PST

under the Provincial Sales Tax Act

#### **GENERAL INFORMATION**

As a real property contractor, you may use a fully completed copy of this form as qualifying evidence that your customer agrees to pay provincial sales tax (PST) on goods you acquire to fulfil a contract to supply and affix, or install, those goods so they become part of real property.

#### INSTRUCTIONS FOR CUSTOMERS AND CONTRACTORS

#### Part A – Customer Information and Declaration

Your customer completes this part. The customer must be a person with whom you entered into the real property contract.

#### Part B - Contractor Information and Declaration

You, the contractor, complete this part. As the contractor, you are responsible for paying provincial sales tax (PST) on goods you supply under a contract that requires you to affix or install affixed machinery or an improvement to real property. If the machinery or improvement is situated in B.C., you may claim an exemption from paying PST on goods that become part of the machinery or improvement if you and your customer agree that your customer is responsible for paying PST on the goods.

There must be evidence of that agreement, such as a fully completed copy of this form. See **Bulletin 501**, Real Property Contractors, for other evidence that can qualify.

If you use this form as evidence, keep it in your records to prove you qualify for the exemption and to show why you collected PST from the customer. Claim the exemption using your PST number or, if you have not yet received your PST number, a fully completed Certificate of Exemption Contractor (FIN 491). Your exemption from PST is restricted to the goods identified in Part B of this form.

**Note:** if you claim the exemption, you must be registered for PST before supplying the goods to be affixed, or installed into real property and you must remit all PST you collect from your customer.
