EXECUTIVE COUNCIL CHAMBERS, VICTORIA JUN. 1 0 1976

Pursuant to the Mineral Act and Placer Mining Act, and upon the recommendation of the undersigned, the Lieutenant-Governor, by and with the advice and consent of the Executive Council, orders that

(1) no person shall locate upon and no free miner shall stake on any of the lands within the following described area in the Vancouver Mining Division, Group 1, New Westminster Land District:

Commencing at the south-west corner of Lot 6590, Group 1, New Westminster District; thence easterly along the southerly boundary of said Lot 6590 to the westerly boundary of Highway Plan 142; thence in a southerly direction along the said westerly boundary of Highway Plan 142 to the northerly boundary of Lot 7091; thence westerly, southerly and easterly along the northerly, westerly and southerly boundaries of said Lot 7091 to the north-west corner of Lot 6972; thence southerly along the westerly boundaries of said Lot 6972 and Lots 6639 and 6973 to the northerly boundary of Lot 6591; thence westerly along the said northerly boundary of Lot 6591 to the northerly limit of Waugh Lake - Egmont Road right-of-way, said northerly limit lying parallel to and 33 feet perpendicularly distant northerly from the centre line of said road; thence in a general westerly direction along the said northerly limit of Waugh Lake -Egmont Road right-of-way to the westerly boundary of Lot 2943; thence northerly along the said westerly boundary of Lot 2943 to the south-west corner of Lot 2357; thence easterly and northerly along the southerly and easterly boundaries of said Lot 2357 to the aforesaid south-west corner of Lot 6590, being the point of commencement.
