THIS AGREEMENT is made effective the 28 day of Neurober, 2006.

(the "Licensee")

## WHEREAS:

- A. In accordance with the *Forest Act*, the Minister and Licensee entered into a replacement agreement for Tree Farm Licence (TFL) 5, dated March 1, 2000 and TFL 52, dated, January 1, 2001, and
- B. The Licensee requested the consolidation of TFL 5 and TFL 52 under Section 39 of the *Forest Act*, and
- C. The Minister considers the consolidation would not compromise forest management, and
- D. The lands subject to TFL 5 are to be deleted from TFL 5 and added to TFL 52, and
- E. The British Columbia Timber Sales portion of the allowable annual cut from TFL 5 will be added to TFL 52; and

F. The *Forestry Revitalization Act* portion of the allowable annual cut from TFL 5 will be added to TFL 52.

## THEREFORE:

In accordance with Section 39 of the *Forest Act*, the Minister, with the consent of the Licensee, agrees to add all lands deleted from TFL 5, in accordance with Instrument No. 12 to TFL 5, to the license area of TFL 52.

The British Columbia Timber Sales portion of the allowable annual cut of 5,454 m<sup>3</sup> per year, from TFL 5, will be added to TFL 52; and

The *Forestry Revitalization Act* portion of the allowable annual cut of 36,485 m<sup>3</sup> per year, from TFL 5, will be added to TFL 52.

This agreement has been executed by the Licensor and Licensee on the day and year first written above.
