IN THE MATTER OF THE MINERAL TENURE ACT S.B.C. 1988, C.5

PLACER MINERAL RESERVE

By the authority vested in me under the provisions of Section 18, I hereby establish a mineral reserve for placer minerals to be effective August 15, 1988, over the land specified in Schedule A attached.

No free miner shall locate or record a placer claim in the mineral reserve created by this Regulation.

SCHEDULE A

All mineral lands within the province of British Columbia, save and except

- a. all reserves established under Sections 1 and 20 of the Mining (Placer) Act, and
- b. Areas 1 to 6, Foxy Creek #2, Goldrun Creek and Hellroaring Creek described as follows:

All that parcel or tract of land together with all that foreshore or land covered by water, more particularly shown outlined in black on the attached sketch, save and except Foxy Creek and all that parcel or tract of land together with all that foreshore or land covered by water lying between the present natural boundaries of the left and right banks of Foxy Creek and a line parallel to and 10 m perpendicularly distant from the present natural boundaries on the said left and right banks of Foxy Creek.

GOLDRUN CREEK - Atlin Mining Division, Cassiar Land District, Atlin Electoral District







HELLROARING CREEK








