Hundred and Sixty-three,

BETWEEN:

THE MINISTER OF LANDS, FORESTS, AND WATER RESOURCES  
of the Province of British Columbia, who, with his  
successors in office, is

hereinafter called "the Minister", of the one part,

AND

B.C. INTERIOR SAWMILLS LTD., a corporation duly  
incorporated under the laws of the Province of  
British Columbia, and having its registered office  
in the City of Kamloops, in the said Province,

hereinafter called "the Licensee" of the other part.

WHEREAS pursuant to the provisions of Section 36 of the  
Forest Act, the Minister and the Licensee entered into an Agreement  
dated the 8th day of September 1959 known and referred to as the  
"Jamieson Creek Tree Farm Licence" which is numbered 35 on the Forest  
Service register of Tree Farm Licences and on the official atlas maps  
of the Department of Lands, Forests, and Water Resources.

AND WHEREAS the parties hereto have mutually agreed to amend  
the said Indenture as hereinafter set forth.

NOW THEREFORE THIS INDENTURE WITNESSETH THAT in consideration  
of the premises and the sum of One Dollar (\$1.00) of lawful money of  
Canada now paid by the Licensee to the Minister, receipt whereof is  
hereby acknowledged, the parties hereto agree as follows:

- (1) That Schedule "B" of the said Indenture dated the 8th day of  
September, 1959 be and it is hereby amended to include that parcel or  
tract of Crown land more particularly described as follows:

"Commencing at a point approximately 825 feet north and 462 feet east of the southwest corner of Section 10, Township 23, Range 17, W6M; thence south 53° 49'40" east 600 feet; thence north 36° 10'20" east 600 feet; thence north 53° 49'40" west 600 feet; thence south 36° 10'20" west 600 feet more or less to the point of commencement."

(2) That the parties hereto, subject to the terms of this Indenture, confirm in all other respects the said Indenture dated the 8th day of September, 1959.

(3) This Indenture shall be binding upon the Minister and his successors in office, and upon the Licensee, its successors and assigns.

IN WITNESS WHEREOF the Minister has executed these presents and the Licensee has hereunto affixed its corporate seal by the hands of its proper officers in that behalf.
