INFORMATION ON HOW TO REVOKE AN APPOINTMENT OF ATTORNEY FOR AN EXTRAPROVINCIAL COMPANY

Thank you for your request on how to revoke an appointment of attorney for an extraprovincial company under section 393 of the *Business Corporations Act*.

STEP ONE

In order to revoke an appointment of an attorney, an extraprovincial company must file a Notice of Revocation of Appointment of Attorney (Form 40) with the registrar. The revocation takes effect at the beginning of the day following the date on which the notice is accepted and filed with the registrar.

An extraprovincial company cannot revoke the last attorney on file, unless it has, under its charter, a head office in British Columbia.

Note: A revocation of the appointment of an attorney does not take effect unless and until the extraprovincial company complies with section 386 of the Business Corporations Act.

Section 386 requires that every extraprovincial company must have at least one attorney unless, under its charter, its head office is in British Columbia. Each attorney is deemed to be authorized by the extraprovincial company to accept service and to receive notices.

After a revocation of the appointment of an attorney takes effect, the registrar will furnish confirmation of the revocation of appointment to the person whose appointment has been revoked.

STEP TWO

In order to satisfy the requirements of section 386, the extraprovincial company may have to appoint a new attorney. In order to appoint a new attorney, complete and submit to the registrar a Notice of Appointment of Attorney (Form 38).

The appointment of an attorney is effective on the date and time the Notice of Appointment of Attorney is filed with the registrar.

When the registrar receives and accepts the Notice of Appointment of Attorney, the registrar will provide confirmation of the appointment to the person identified as the new attorney.

Note: Failure to comply with the requirement of section 386 of the Business Corporations Act will result in the cancellation of the registration of the extraprovincial company.

FEES

The fee to file either a Notice of Revocation of Appointment of Attorney (Form 40) or a Notice of Appointment of Attorney (Form 38) is \$20 for each filing.

All notices are processed on a first-come, first-served basis unless you pay an additional priority fee. If you wish the notice to be processed on a *priority basis*, an additional \$100 will be required. If the notice is being submitted on a priority basis, clearly indicate on both the envelope and the notice that the submission is a priority.

A priority service is considered completed when the document is filed or the service request is completed. Turnaround is usually within 24 hours.

Note: If a document to be filed has errors and requires correction, then those corrections must be made and returned to this office within the 24 hour period to maintain priority status.
