

Low Carbon Fuel Standard TFRS Registration Form A

(Required for organizations WITH compliance obligations)

Organizations with compliance responsibilities under the Low Carbon Fuels Act require a Transportation Fuels Reporting System (TFRS) account to manage their compliance obligations. Before completing this form and gaining access to TFRS, organizations need to register with BCeID and have a Business BCeID user account created for each company representative. The Business BCeID registration process is managed by the BCeID Help Desk, and all inquiries regarding the sign-up process or issues with your BCeID account should be directed there. Once a Business BCeID user account has been created, please complete this form accordingly.

Instructions: Please have the designated administrator or primary contact person of your organization complete all applicable fields of this form. Attach all accompanying documents required for review to this form and return via email to the Low Carbon Fuels Branch (LCFB) general inbox for processing at lcfs@gov.bc.ca. After submission, the documents will be reviewed, and an administrator will be in contact with you. Upon registration approval, a Transportation Fuels Reporting System (TFRS) account will be created, and the managing user of the account can add additional users and manage account settings as required.
