PRFN HAS REQUESTED EARLY ENGAGEMENT TO PROVIDE THE PROPONENT WITH THE OPPORTUNITY TO ADDRESS PRFN INTERESTS PRIOR TO SUBMITTING AN APPLICATION TO THE OIL AND GAS COMMISSION.
