# NEW COVERAGE FOR NICOTINE REPLACEMENT THERAPIES — PATCHES AND GUM

On May 9, 2011, <u>Premier Christy Clark announced</u> that, starting **September 30, 2011**, the province would make nicotine replacement therapies (NRTs) available to all British Columbian smokers at no cost.

In response to this commitment, the Ministry of Health held a competition for the exclusive supply of NRT patch and gum products for use in the B.C. Smoking Cessation Program.

Following the successful completion of this competition, the Ministry of Health is pleased to announce that, effective **September 30, 2011**, PharmaCare will cover the following NRT patches and gum as Limited Coverage benefits:

PharmaCare will not be covering any other brands of nicotine replacement therapy gums or patches, or any other nicotine replacement therapy products as part of the B.C. Smoking Cessation Program.

The listed products will, subject to treatment course limits, be 100% covered for eligible B.C. residents and will be available by direct mail from the Province or through community pharmacies.

Since these are the only nicotine replacement therapy gums and patches that PharmaCare will cover, pharmacies may want to assess their current stock levels for these products. Orders for these products can be placed with pharmacy distributors in the usual way.

The maximum that pharmacies can claim from PharmaCare for the above products is the list price, plus the 8% mark-up and the maximum dispensing fee. Pharmacies should note that coverage for the above products under this plan is not income tested and therefore, there are no deductibles to be reached prior to a patient becoming eligible for reimbursement or for the Full Payment Policy to apply. As a reminder, under the Full Payment Policy, pharmacies must not charge a 'co-payment' to patients who are receiving full coverage under a PharmaCare plan.
