The purpose of this letter is for Centermount Coal Limited to formally give support to Teck Coal Limited for the Elk Valley Water Quality Plan proposed by Teck Coal. Centermount Coal has been named as a Stakeholder in the Elk Valley as ordered by the Minister of the Environment.

Centermount Coal Limited holds four mining licenses in the Elk Valley, known as Bingay Creek Coal Project, which is adjacent to Teck Coal's Fording Operations. The project has completed its Pre-feasibility Study Stage and is in the very early stage of the Environmental Assessment Process.

Teck Coal Ltd planning for water quality is feasible and practical. It has met at a Senior Management level between the two companies to ensure cooperation on environmental issues such as water quality. Teck has followed by supplying any technical documents and advice needed for environmental studies. Although the Bingay Project differs from Teck Coal's operation with Bingay being a valley bottom coal deposit while Teck's operations being mountain top mining; both companies understand the need for flexibility with respect to longer term commitments to understand the impacts and success of the initial mitigation measures before the measures are replicated. This cooperation is necessary so that there is unity within the Elk Valley coal operations with success being a team effort by all parties.

Centermount Goal Ltd. strongly supports Teck Coal Ltd. in proposing the Water Quality Plan and wishes them success in this effort.
