**WHEREAS:**

- A. Pursuant to the provisions of the *Forest Act*, the Licensor and Licensee entered into a replacement agreement for Tree Farm Licence 54, dated June 1, 2002, and
- B. The Licensee and the Licensor have mutually agreed to change the area of Tree Farm Licence 54 by removing approximately 123 hectares of private land subject to the Tree Farm Licence.

In accordance with Section 39.1(2)(b) of the *Forest Act*, the Licensors, with the consent of the Licensee, hereby changes the area of Tree Farm Licence 54 by removing the private lands subject to the Tree Farm Licence agreement as described on the attached Exhibit "A" map.
