1. B.C. Reg. 428/79 be repealed
2. The following described land in the Cariboo and Clinton Mining Divisions, Lillooet Land District, is established as a Mineral Reserve and as a Placer Mining Reserve:

Commencing at the most northwesterly corner of Lot 1 of Lot 44 as shown on plan 25034, deposited in the Land Title Office at Kamloops; thence southerly along the westerly boundary of said Lot 1 of Lot 44 and its southwesterly prolongation to the natural boundary of the Chilcotin River on the right bank thereof; thence in a general southeasterly direction along the said natural boundary of the Chilcotin River on the right bank thereof to the confluence of the Chilcotin River and the Fraser River; thence due east to the natural boundary of the Fraser River on the left bank thereof; thence in a general northerly, easterly, direction along the said natural boundary of the Fraser River on the left bank to a point due east of the northeast corner of Section 13, Township 48; thence westerly to the said northeast corner of Section 13; thence due west 1400 metres; thence due south 1400 metres; thence due west 1800 metres; thence due south 900 metres; thence due west 3200 metres; thence due south to the northerly boundary of Lot 536, Lillooet Land District (formerly Cariboo Land District); thence easterly and southerly along the northerly and easterly boundaries of said Lot 536 to the northeast corner of Lot 538, Lillooet Land District (formerly Cariboo Land District); thence southerly along the easterly boundary of said Lot 538 a distance of 1500 metres;




