IN THE MATTER OF TREE FARM LICENCE NUMBER 47 INSTRUMENT NUMBER 1

Amendment

Whereas Tree Farm Licence Number 47 on the Forest Service Register of Tree Farm Licences and known as the Duncan Bay Tree Farm Licence or Tree Farm Licence Number 47 was replaced by a new document dated January 1, 1985.

And whereas it has now been found that the legal description and Key map of Block A "Moresby Block" of Schedule 'B' land is defective;

Therefore, the lands herein described are herewith added to Schedule 'B' of the said Tree Farm Licence and shall be and are hereafter and now subject to all the terms and conditions of the said Tree Farm Licence as if the said lands had been originally included as part of the lands subject to the said Tree Farm Licence.

Commencing at the northeast corner of Section 5, Township 1, Rupert Land District; thence easterly along the southerly boundary of Section 8, Township 1 to the southeast corner thereof; thence northerly along the easterly boundary of said Section 8 to the northwest corner of the south half of Section 9, Township 1; thence easterly along the northerly boundary of the south half of said Section 9 1.235 kilometres; thence south 420 metres to the northerly limit of Highway 19, Plan 2038; thence in a general northeasterly direction along the northerly limit of said Highway 19, Plan 2038, to the easterly boundary of aforesaid Section 9, Township 1; thence southerly along the easterly boundary of said Section 9 to the most northerly northeast corner of Lot 395; thence westerly along the northerly boundary of said Lot 395 to the northwest corner thereof; thence south 82 degrees 10 minutes 30

seconds west 20.161 metres to the northeast corner of Lot 394; thence westerly and southerly along the northerly and westerly boundaries of said Lot 394 to the southerly boundary of the north half of Section 4, Township 1; thence westerly along the southerly boundary of the north half of said Section 4 755 metres, more or less, to the high-water mark of an unnamed creek on the left bank thereof, said unnamed creek flowing northerly into Hyde Creek at a point 120 metres north and 495 metres east of the northeast corner of aforesaid Section 5, Township 1; thence in a general southeasterly direction along the high-water mark of said unnamed creek on the left bank thereof to a point on the northerly limit of a public road, said point being 630 metres south and 570 metres east of the northeast corner of said Section 5, Township 1; thence in a general northwesterly and westerly direction along the northerly limit of said public road to the westerly boundary of aforesaid Section 4, Township 1; thence northerly along the westerly boundary of said Section 4 to the point of commencement.

Containing 209 hectares, more or less.
