Emission Reductions: Actions & Plans

A. Stationary Sources (e.g. buildings, power generation)

2021 was a challenging year for all, our district focus was keeping schools open and safe for students and staff. Despite all that happened, staff absenteeism, supply chain issues etc. the district was still able to push forward with upgrades to reduce our emissions.

Our Lillooet Secondary was in the final phase of the Geothermal upgrade which will reduce our energy consumption and provide emission reductions. This will be complete in the Spring of 2022.

The devastation of Lytton heavily impacted our progress on our K-12 school. It was in the process of an electrical and mechanical upgrade but was stopped due to the fires. We will be picking this up again to become a success story for 2022.

B. Mobile Sources (e.g. fleet vehicles, off-road/portable equipment)

In 2021, with the extreme weather conditions we faced, it brought forward the need to look at electrification of our fleet. A study took place to investigate the viability and costs associated in upgrading our infrastructure to accommodate this venture. Currently, our transportation facilities are unable to support electrification until we upgrade to three phase power. This is costly. School District No. 74 will be making a submission to the Ministry for funding to support this endeavor.

C. Paper Consumption
