Re: Notice Letter, Permit 5768, W. Redona Island, Doctor Bay

On March 16, 2018, Ministry of Environment and Climate Change Strategy, Environmental Protection Division staff conducted an office review inspection of your facility, Saltstream Engineering Ltd. located at W. Redona Island, Doctor Bay Fish Processing Plant with authorization number 5768 under the *Environmental Management Act*.

Inspection Details:

Requirement Description:	Appendix 03, Clause A: (A) The discharge of effluent to wich this appendix is applicable is combined effluent from a fish hatchery and a fish processing plant approximately located as shown on the attached Appendix A-1.
Details/Findings:	On January 26, 2018, Officer Laura Hunse spoke with Rob Smeal, Site Manager at Saltstream Engineering Ltd. (Saltstream) by phone to discuss Permit 5768. Mr. Smeal confirmed that the Saltstream Engineering Ltd. (Saltstream) has not been involved with processing fish since the mid-1990s and only operates a fish hatchery now. The fish hatchery is registered under the <i>Environmental Management Act</i> 's Land-based Finfish Waste Control Regulation (registration number RE-17301, registration date January 30, 2003); therefore compliance with this permit is not applicable.
Compliance:	Not Applicable
Actions to be taken:	As the fish processing discharge portion of Permit PE-5678 is no longer occurring and has not occurred for more than 20 years, and as the hatchery discharge portion of the permit is covered by registration RE-17301 under the Land-based Finfish Waste Control Regulation, it is recommended that Saltstream request cancellation of the permit.
