# **TFL 48 AMENDING AGREEMENT**

THIS AGREEMENT is dated October 30, 1998.

#### **BETWEEN**

HER MAJESTY THE QUEEN IN RIGHT OF THE PROVINCE OF BRITISH COLUMBIA, represented by the Minister of Forests, Parliament Buildings, Victoria, British Columbia V8V 1X4

(the "Licensor")

#### AND

CANADIAN FOREST PRODUCTS LTD. (Inc. No. 0510996), a company duly incorporated under the *Company Act*, and having an office at 2800 - 1055 Dunsmuir Street, P. O. Box 49420, Bentall Postal Station, Vancouver, British Columbia V7X 1B5

(the "Licensee")

#### WHEREAS:

- A. Under the Rice Agreement, the Licensee caused
  - (i) the Rice Property to be transferred to the Licensor; and
  - (ii) the lessees under the agricultural leases of the Agricultural Land to permit those leases to expire.
- B. Pursuant to paragraph 38(1)(b) of the Forest Act, the Licensor has determined that the Rice Property and the Agricultural Land are contiguous to the tree farm licence area of TFL 48 and the Chief Forester has determined that forest management will be improved

by the addition of the Rice Property and the Agricultural Land to the tree farm licence area described in Schedule "B" of TFL 48.

D. ne parties enter into this Agreement pursuant to subsection 38(2) and paragraph 39(1)(e) of the Forest Act.

The parties agree as follows:

### ARTICLE I - DEFINITIONS

- 1.01 In this Agreement,
  - "Agricultural Land" means the land described in Appendix "1" to this Agreement;
  - "Rice Agreement" means the agreement dated for reference July 15, 1998 between the Licensee and the Licensor concerning the transfer of the Rice Property to the Licensor;
  - "Rice Property" means the land described in Appendix "2" of this Agreement; and
  - "TFL 48" means Tree Farm Licence Number 48 made between the Licensor and the Licensee on December 1, 1988.

### ARTICLE II - AMENDMENT OF TFL 48

2.01 Pursuant to subsection 38(2) of the Forest Act, TFL 48 is amended to add the Rice Property to the tree farm licence area described in Schedule "B" of TFL 48



- 2.02 Pursuant to paragraph 39(1)(e) of the Forest Act, TFL 48 is amended to add the Agricultural Land to the tree farm licence area described in Schedule "B" of TFL 48.
- 2.03 Pursuant to paragraph 39(1)(e) of the Forest Act, the Licensee consents to the amendments of TFL 48 referred to in this Agreement.

### ARTICLE III - INTERPRETATION

3.01 A reference to a statute in this Agreement is a reference to a statute of the Province of British Columbia and, unless otherwise stated, includes every amendment to it, every regulation made under it and every enactment made in substitution or replacement of it.

- Unless the context otherwise requires, all references to this "Agreement" include all appendices attached to it and each appendix attached to this Agreement is an integral part of this Agreement as if set out at length in this body of this Agreement.
- 3.03 The headings and captions contained in this Agreement are for convenience only and do not define or limit the scope or intent of this Agreement.
- 3.04 The parties will perform such further acts and execute such further documents as may reasonably be required to give effect to this Agreement.
- 3.05 This Agreement will be interpreted according to the laws of the Province of British Columbia.
