#### Claire,

As you know, the BCFIRB has lifted the moratorium on agency applications, but it has not yet ruled on CFP's appeal from the Commission's June 23, 2019 decision to summarily dismiss CFP's application for designated agency status (the "Decision").

On September 3, 2019, after CFP had commenced its appeal from the Decision, you requested that the Commission "reconsider" the Decision in light of the fact that Mr. Les had since resigned as a director of CFP. On September 12, 2019, I wrote to you as follows:

It is the Commission's respectful position that a multiplicity of proceedings and applications is to be avoided. While CFP's appeal in relation to the Decision is extant, the Decision should not also be made the subject of other concurrent proceedings or application brought by CFP.

In short, until the appeal brought by CFP is dealt with in some manner, CFP's application for "reconsideration" is premature, and would otherwise give rise to an unnecessary multiplicity of proceedings.

I am instructed to advise that the Commission's view has not changed. However, I am further instructed to advise that if CFP abandoned its extant appeal before the BCFIRB, as well as any proceedings before the BC Supreme Court regarding that application for designated agency status, there would be no impediment to the Commission reconsidering the application given that the moratorium has been lifted by the BCFIRB.

Please let me know how you would like to proceed.

#### Claire,

I am instructed that the Commission has established a panel to consider applications for designated agency status from persons that intend to market storage crops, and another panel to consider applications for designated agency status from persons that intend to market greenhouse vegetables. Each panel will consider all of the applications that are then before it at the same time. Complications could arise in the event that the Commission is presented with applications for designated agency status from persons that intend to market both storage crops and greenhouse vegetables. In that event, it is likely that a third panel would need to be struck, in which case such applications could be considered either before or after applications that are focused exclusively on storage crops or greenhouse vegetables.

Finally, the Commission is unable to be any more specific about when decisions will be made on applications, other than to reaffirm that it intends to address such applications in a timely manner. The Commission cannot anticipate every issue that might arise on an application, or what steps might need to be taken to address those issues.
