

Community Safety Unit Form No. CSU150

PURPOSE:

This Application for Reconsideration form may only be used to apply for a reconsideration of a Compliance Order issued under section 94 of the *Cannabis Control and Licensing Act* (CCLA). **The completed Application for Reconsideration form must be received by the Community Safety Unit (CSU) within 30 calendar days from the date that the applicant received the Compliance Order for which reconsideration is sought** (see section 41 of the Cannabis Licensing Regulation for rules about how to determine when a Compliance Order is deemed received). A Concession Order, which is an order made following the receipt of a signed waiver, cannot be reconsidered.

INSTRUCTIONS:

You must complete all applicable fields and submit the completed Application for Reconsideration form, along with the submissions, new evidence (if applicable) and the application fee of \$500 (or proof of payment) to the CSU by mail, email or fax. If the form is incomplete or the application fee is not paid in full, this Application for Reconsideration will be rejected.

You will be notified if the Application for Reconsideration is accepted or rejected. If accepted, the reconsideration hearing will proceed on a review on the record, which includes your enclosed submissions and, if applicable, new evidence.

If you intend to apply for an oral hearing, you must do so at the same time as you submit the Application for Reconsideration. The Application for Oral Hearing form is available on the CSU's website.

If more than 30 calendar days have passed since you received the Compliance Order, you must submit a written request for an extension of time before the Director will consider this application. An extension of time will not be granted unless you can establish there were special circumstances that prevented you from meeting the deadline and an injustice would result if an extension of time is not granted. You must provide your written argument and any supporting evidence with your extension request, which must be sent to the CSU by mail, email, or fax. You will be notified if the extension request is accepted or rejected.

Note: If you would like an individual to represent you during the reconsideration hearing process and have the CSU share your personal information with your representative, you must complete and submit an Authorization of Representative form, if one has not previously been submitted. A corporation, including a society, must submit an Authorization of Representative form with their Application for Reconsideration. The Authorization of Representative form can be found on the CSU website.

Part 2: Applicant's Submission

As specified in sections 95(3) and (4) of the CCLA, a reconsideration may be based on only one or more of three specified grounds (listed below). Pursuant to section 95(5) of the CCLA, you must identity one or more of the following grounds that apply to your reconsideration application:

□ New evidence that is substantial and material to the reconsideration and did not exist when the Compliance Order was made or did exist at that time but was not discovered and could not, through the exercise of reasonable diligence, have been discovered (if this ground applies you are also required to attach the new evidence).

 \Box A failure to observe the rules of procedural fairness.

□ An error of law, other than an error of law respecting a constitutional question, including, but not limited to, a constitutional question that requires notice to be given under section 8 of the *Constitutional Question Act*.

Furthermore, section 95(5) requires that you include your submissions setting out your argument with respect to the grounds for reconsideration identified above. The 3 grounds listed above are the only reasons the Director may reconsider a Compliance Order.

Note: You must enclose your submissions (written argument and, as applicable, new evidence) with this form. As the applicant, you carry the burden of proof.

Part 3: Fee Payment

The reconsideration application fee is \$500.00 and is not refundable unless the Compliance Order is rescinded by a Reconsideration Order. The application fee can be paid by credit card, certified cheque, or money order.

Note: If the application fee is not paid in full, this Application for Reconsideration will not be accepted.

Credit card payments can be paid through an Express Pay link on the CSU website. If payment is made by credit card, the payor must provide proof of payment by emailing <u>CSU@gov.bc.ca</u> the payment confirmation page with the transaction ID number.
