

## **Pesticide Sales Record**

FORM REFERENCE CODE: EPD-IPM-07.3

## **INSTRUCTIONS:**

Complete a pesticide sales record for every sale of Commercial, Restricted or Permit-restricted class pesticide.

For sales of Restricted and Permit-restricted pesticides, you must record the purchaser's Applicator Certificate number. For sales of **second-generation anticoagulant rodenticides** (SGARs) containing the active ingredient brodifacoum, bromadiolone, or difethialone, you must record the following information:

- Licensee name and licence number
- Certified pesticide applicator name and certificate number
- For non-service licensees, the category of Essential Service location where the SGAR will be used.

Pesticide sales records must be kept for a period of three (3) years following the pesticide sale and must be made available to the ministry upon request.

Please note that while a record of each pesticide sale is required, the use of this specific form is voluntary. Many vendors choose to use their own systems to record the required information. This information is used to generate an annual sales summary.

Abbreviations or codes may be used to complete this record only if a key to the abbreviations and codes is attached to this form.

<sup>&</sup>lt;sup>3</sup> For all purchasers of second-generation anticoagulant rodenticides (SGARs), record the licence name and licence number. For **non-service** licensees, record the category of essential service location where the SGAR will be used. Essential service locations are listed in Schedule 6 of the Integrated Pest Management Regulation.
