Dear Eric Schroff:

On November 22, 2001, I did not approve the Job Creation Plan (JCP) submitted by Iisaak Forest Resources Limited (Iisaak). The JCP was to recover the 5 percent Crown land allowable annual cut (AAC) reduction (5145 m³) resulting from the October 27, 1999, transfer of Tree Farm Licence (TFL) 57 from MacMillan Bloedel to Iisaak.

In accordance with Section 56 (9) of the Forest Act, I have decided to allocate the AAC reduction to non-replaceable timber sale licences within the area of TFL 57, effective 14 days after consent to the transfer was given (November 10, 1999). Attached is an updated AAC summary for TFL 57. The updated AAC summary replaces those provided by Jim Langridge, Director, Resource Tenures and Engineering Branch, and Ken Baker, Deputy Chief Forester, in letters to you dated June 26 and July 4, 2000, respectively.

This letter amends Section 1.09 (a) of TFL 57 dated October 27, 1999, by deleting "8265 m<sup>3</sup> of the allowable annual cut" and substituting "13 410 m<sup>3</sup> of the allowable annual cut."

This letter is an integral part of the TFL 57 agreement and should be attached thereto.
