Thank you for your Draft Management Plan#3 for TFL 53 dated June 30, 1999. I would like to commend Dunkley Lumber (Dunkley) for the thoroughness and quality of this submission. I am in agreement with the content of your plan with the exception of the following sections where clarification is required:



- 1.1 Description of Tree Farm Licence # 53: This section refers to a Figure 1. Please clarify where Figure 1 is located.
- 2.3 Recreation Inventory: This section states that no further activity is planned on the recreation inventory during the term of Management Plan #3 The tree farm licence document requires that the inventory information used for the next management plan meet the standards current at that time. The recreation inventory for the TFL was last updated in 1994. The Ministry of Forests standards for recreation inventory were updated in 1998. Please ensure that the recreation inventory is updated to the latest standards prior to Management Plan #4.
- 2.6 Landscape Inventory: This section states that no further activity is planned on the landscape inventory during the term of Management Plan #3. I would prefer to see the landscape inventory updated during the term of the new management plan. Over the term of the management plan, screening effects may change, blocking existing views or creating new ones. The Existing Visual Condition of certain units may also have changed. This update would be a relatively minor workload, but important to ensure that updated information is used for the next timber supply analysis.

- 2.9 Cultural Heritage Resources: This section states that there are no known cultural heritage resources on TFL 53. It is my understanding that an archaeological site and trail have been located on the TFL. Please ensure that this section makes reference to this archaeological site and trail.
- 3.1.2 Utilization Standards: The Management Plan and Timber Supply Analysis propose a partitioned cut for deciduous timber. This section should specify what the deciduous utilization standards will be on the TFL. It is my expectation that these standards will meet or exceed the standards specified in the timber supply analysis.
- 3.1.3.1 Balsam Intermediate Utilization: The Management Plan proposes that the remaining Balsam IU rehabilitation stands be considered part of timber profile of the TFL harvesting landbase and not be treated as a partition. The Statement of Management Options, Objectives and Procedures stated that it was Dunkley's objective to establish a partitioned cut for these stands. I am not entirely comfortable with Dunkley's proposal to add these stands into the harvesting landbase, and I am concerned with this change in objectives. The final decision on how to proceed with these stands will be determined by the chief forester. If Dunkley support a partitioned cut for these stands, this should be reflected in the management plan.
- 3.1.3.2 Deciduous Stands: The Management Plan proposes that a deciduous partition be introduced and that a portion of the TFL volume be maintained in deciduous stands. I support this proposal for the term of Management Plan #3. However, I am not able to give this proposal long-term consideration without further information. I request that Dunkley complete a more detailed plan for deciduous management on the TFL for consideration in Management Plan #4.
- 3.1.4 Proposed Allowable Annual Cut: This section states that it is Dunkley's objective to increase the allowable annual cut to supply at least 60 percent of the mill capacity. The Statement of Management Objectives Options and Procedures stated that it is Dunkley's objective to increase the allowable annual cut to supply at least 50 percent of the mill capacity. Please provide a rationale for changing this objective.

The proposed allowable annual cut (AAC) of 249 000 m³ will result in small decrease in the mid term harvest level. It is my understanding that Dunkley accepts this anticipated decrease and that the company is prepared to purchase additional private wood at the time of the decrease in order to sustain operations at the mill. This section should include a short discussion of this mid term decrease in harvest level as well as a rationale as to how Dunkley will address this reduction in fibre supply.

4.1 Fire Prevention: The Fire Pre-Organization plan should be submitted to the Ministry of Forests Fire Center in Prince George, not to the district manager.

8.2.2 Other Planning Initiatives of Approved Plans: This section makes reference to the Prince George Land and Resource Management Plan (LRMP). Dunkley is signatory to the LRMP and has stated that the plan will be used to guide management activities on the TFL. In this respect, I expect this section will include a statement to confirm that Dunkley will ensure that the forest development plan, is consistent with the LRMP.

This completes my review of the draft Management Plan #3. I look forward to receiving Dunkley's proposed management plan by October 1, 1999.
