Executive Summary

2011 Greenhouse Gas Emissions

Heating, lighting, ventilation and other building operations necessary to maintain a healthy patient and workplace environment resulted in the emission of fifty-four tonnes of carbon and carbon equivalents into the atmosphere. In addition, paper consumption added the release of four tonnes of carbon equivalent emissions. In total, Wrinch Memorial Hospital had a measured carbon footprint of fifty-eight tonnes for the delivery of healthcare in the community of Hazelton and surrounding rural population.

Offsets Applied to Become Carbon Neutral in 2011

Wrinch Memorial Hospital purchased fifty-eight tonnes of carbon offsets to counter the emissions identified above, thereby achieving carbon neutrality in accordance with, and as defined by, government legislation.

Emissions Reduction Activities

Wrinch Memorial Hospital continued its ongoing efforts in 2011 to reduce carbon emissions from its operations.

Actions Taken to Reduce Greenhouse Gas (GHG) Emissions in 2011

Understanding where opportunities may lie, an energy audit of the facility was undertaken in 2011. This study identified opportunities for energy savings and carbon emissions reductions which will be considered in our ongoing facility project planning.

Recognizing that well maintained equipment runs more efficiently, Wrinch continued its efforts to keep all equipment maintenance up to date.

As in previous years, Wrinch continues to minimize its GHG footprint from carbon based fuels by selecting to heat its facility primarily through the use of electricity, which has a significantly lower carbon footprint than fossil fuels.

Through its partnership with Northern Health, Wrinch is an active partner in the BC Hydro Power Smart program and was pleased to take advantage of partner funding to support the cost of the energy audit.

Helping to reduce emissions generated by our staff and patients, we continue to partner with BC Transit to provide public transit service directly to the front door of our facility.

Plans to Continue Reducing Greenhouse Gas Emissions

In 2012 and going forward we will continue to improve building systems, including energy-efficient solutions as funding permits. We look forward to implementing key findings of the energy audit. We will continue to work with our community in community awareness opportunities as they may arise in the

coming year and partner with Northern Health in their own efforts to reduce greenhouse gases.


