We acknowledge that the processing institution is not required to verify that a Direct Deposit has been issued in accordance with the particulars of the Authorization including, but not limited to, the amount, or that any purpose of payment for which the Direct Deposit was issued has been fulfilled by the Province as a condition to honouring a Direct Deposit issued or caused to be issued by the Province on the Account.
- 9. Revocation of the Authorization does not terminate any contract for goods or services that exists between us and the Province. The Authorization applies only to the method of refund and does not otherwise have any bearing on the contract for goods or services exchanged.
- 10. We agree that the information contained in the Authorization may be disclosed to Central 1 Credit Union, as required to complete any Direct Deposit transaction.
