- Continued to support flexible work arrangements that will reduce the draw on energy resources at the office
 and reduce travel and related emissions to and from work. <u>Note:</u> As of March 2020, due to the disruption to
 staff working arrangements caused by the COVID-19, Destination BC focused on maintaining and monitoring
 the remote office needs and productivity of Destination BC employees.
- 2. Continued to move towards digital files to reduce paper consumption.

D. Briefly describe plans your organization has for continuing to reduce your GHG emissions in future years:

- 1. Continue to promote the use of video conferences and conference calls for meetings that would typically require travel. Note: As of March 2020, due to the disruption to staff working arrangements caused by the COVID-19, Destination BC focused on the use of various cloud-based video conferencing services (e.g. Zoom) to virtually meet with others minimizing any form of travel.
- 2. Continue digitization of records.

E. Describe any actions your organization took during 2020 to strengthen its ability to manage the likely effects of climate change in the coming years and decades (e.g., have assessed whether increased frequency of extreme weather events and/or long-term changes in climate will affect your organization's infrastructure, its employees and/or its clients.)

Continued engagement in emergency management planning initiatives with MTAC - Tourism Policy Branch, Emergency Management BC, and with tourism industry partners to enhance emergency preparedness and response efforts necessary to address tourism impacts resulting from natural disasters and emergencies. In relation to Climate Change, Destination BC's commitment to emergency management planning supports the three pillars outlined in "Preparing for Climate Change British Columbia's Adaptation Strategy", to build a strong foundation of knowledge; make adaptation part of Government's business; and assess risks and implement priority adaptation actions in sectors.

Retirement of Offsets:

In accordance with the requirements of the *Climate Change Accountability Act* and Carbon Neutral Government Regulation, **Destination British Columbia (the Organization)** is responsible for arranging for the retirement of the offsets obligation reported above for the 2020 calendar year, together with



any adjustments reported for past calendar years (if applicable). The Organization hereby agrees that, in exchange for the Ministry of Environment and Climate Change Strategy (the Ministry) ensuring that these offsets are retired on the Organization's behalf, the Organization will pay the associated invoice to be issued by the Ministry in an amount equal to \$25 per tonne of offsets retired on its behalf plus GST.
