## WHEREAS:

A. The Licensee is the holder of Tree Farm Licence 39, dated March 1, 2010.
B. The Licensee has provided consent in a letter dated June 15, 2011, to amend Tree Farm Licence 39 in accordance with section 39.1 of the Forest Act, by deleting a portion of Block 1 of Tree Farm Licence 39 as delineated on the attached map.
C. The Licensee completed a legal survey in 2011 along the northwest boundary of. Tree Farm Licence 39 to re-establish the portion of the boundary as indicated on the attached map.

## THEREFORE:

1. In accordance with Section 39.1 of the Forest Act, the Minister and the Licensee agree that Tree Farm Licence 39 is amended, as of the effective date of this instrument, by deleting 3603.5 ha of crown land identified in red on the attached map.
2. In accordance with 'Section 39.1 of the Forest Act, the Minister and the Licensee agree that the Tree Farm Licence 39 boundary is amended to the revised survey lines as indicated on the attached map of Tree Farm Licence 39.
3. For the purpose of Section 8(2) of the Allowable Annual Cut Administration Regulation, the allowable annual cut of the area deleted as described in 1 above is $22,000 \mathrm{~m}^{3} /$ year.
4. Section 2.01 of the Tree Farm Licence 39 document is deleted and replaced with the following:
2.01 Each year during the term of this Licence:
(a) $0 \mathrm{~m}^{3}$ of the allowable annual cut, from the types of timber specified in paragraph 1.03 and from a type of terrain specified in paragraph 1.04, may be disposed of by the Timber Sales Manager within areas agreed to under paragraph 1.12 or specified under paragraph 1.13;
(b) $16,309 \mathrm{~m}^{3}$ of the allowable annual cut may be disposed of pursuant to Section 47.8 of the Forest Act;
