

OPHO Foundational Commitments to Indigenous Peoples Series (Fall 2022)

Background

Clear foundational directions to address Indigenous-specific racism that require disrupting systemic white supremacy. Indigenous voices have rung loud and clear with foundational directions about how we must reset relationships and move towards a desired future. Testimonies of thousands of (intergenerational) survivors of settler colonial harms informed recommendations laid out in the Royal Commission on Aboriginal Peoples¹, the Truth & Reconciliation Commission of Canada's Calls to Action², and the National Inquiry into Missing and Murdered Indigenous Women & Girls Calls for Justice³. BC's provincial government has made commitments to uphold the TRC Calls to Action and MMIW&G Calls for Justice, and provided 10 Draft Principles that Guide the Province of BC's Relationship with Indigenous Peoples.⁴ We have received 335 recommendations across two reports, many which are relevant to public health. In BC, we have three additional foundational directions: The BC Declaration Act⁵ and the related Action Plan⁶, and the In Plain Sight⁷ recommendations. Instructions have been provided; now it is the work of BC institutions to follow them.


Findings from the first round of the OPHO's Action on Foundational Commitments Self-Assessment. Results from the Action on Foundational Commitments Self-Assessment baseline survey in June 2022 indicate significant variability in awareness of and engagement with Foundational Commitments across the OPHO. Survey responses demonstrated that OPHO team members are at various stages of developing the muscles to hardwire foundational commitments into their everyday work. To build those muscles, OPHO teammates shared that they require: enabling leadership, access to dedicated people who can help with the how, and consistent systems and procedures.

Rationale. The OPHO Foundational Commitments to Indigenous Peoples Series aims to ensure all OPHO team members are familiar with each of these sets of instructions, are able to identify the instructions within their sphere of influence, and have the required tools and direction to uphold them in their day-to-day work.




Session 1: UNDRIP








Session 4: OPH	O Accountability

Session 5: BC Cultu	ral Safety & Humility Standard for Health Organizations
Our Teacher(s)	The First Nations Health Authority (FNHA) and Health Standards Organization (HSO) released the BC Cultural Safety & Humility Standard for Health Organizations in June 2022. The Standard was developed with the goal of designing, implementing, and evaluating culturally safe systems. The Standard provides guidance for governments and organizations to implement cultural safety within their policies and practices, as well as address Indigenous-specific racism. Indigenous thought leaders and health professionals from across the province contributed to the Standard's development.
