### 1. Background

<u>Natural Resource (NR) Online Services</u> is a portal that allows clients to access Natural Resource Ministries data, business forms and applications for multiple business areas. NR Online Services contains <u>Smartforms</u> for the submission of natural resource applications.

As a <u>client</u>, you must complete a <u>onetime</u> "<u>Sign up</u>" with NR Online Services to use these Smartforms and to set up individuals, or client <u>representatives</u>, who will be authorized to act on your behalf. The management of authorized individuals to act on your behalf will be an ongoing responsibility of the client to reflect changes in staffing that may occur.

### 2. BCeID is a pre-requisite for NR Online Services Sign-up

You **must** have a Business <u>BCeID</u> account in order to sign up for NR Online Services and submit applications for business use. If you are submitting applications for personal use, you must have a Personal BCeID. Basic BCeID is not accepted in NR Online Services.

If you have a BCeID account already but are unsure if it is a Personal or Business account, you may log into the BCeID site to confirm the account type. If you do not have a BCeID account, you will have to create new one but must have the required identification to complete the BCeID registration process.

All information about acquiring a BCeID can be found on <u>BCeID's</u> website. Please visit them if you have any questions about the registration process.

## 3. Who Needs to Sign Up to Submit an Application Through NR Online Services??

### 3.1. Individuals and Businesses Are Required

Signing up with NR Online Services is mandatory for individuals or businesses who wish to submit applications, or have a representative submit applications on their behalf. Individuals or businesses will use their personal or business BCeID to sign up with NR Online Services.

### 3.2. Client Representatives and Client Managers Are Not Required

Representatives (staff, consultant, agent etc) will be invited by the client (individual or business) to become Client Representatives or Client Managers and act on their behalf through the use of invitations within NR Online Services. **Representatives do not need to sign up with NR Online Services but they will require a business or personal BCeID to log in to the system.** 

There are two ways a Client Representative or Client Manager can obtain a personal or business BCeID:

- 1. They can register themselves by following the required steps
- The client can register them under their business BCeID company profile (Clients can see section <u>5.1 of the Business BCeID Account and Profile Management Guide</u> for instructions on how to set up accounts)

### 4. Signing up to the NR Online Services With a Business BCeID

The Business NR Online Services sign up uses BC Registries information for businesses that are registered with them. For clients who are not registered with BC Registries, your BCeID information will be used for sign up.

### 4.2. Overview of the NR Online Services Dashboard

- 1. Account Name: The name of the NR Online Services account associated with the BCeID sign in credentials
- 2. Log Out: Click to log out of NR Online Services
- 3. Dashboard and Account Settings links: These are visible on all pages of NR Online Services
- 4. **New Applications**: A list of the most recent applications submitted through NR Online Services. If you have not submitted an application yet, some guidance will be displayed here.
- 5. Add New Application: Click to start a new application through NR Online Services
- 6. **Account Settings**: This area is where you can view permissions, manage agents, contact information and financial profile
- 7. Add New Agent(s): Click to add a new representative to act on the client's behalf
- 8. Tools and Resources: A list of helpful links to Natural Resource information and activities
- 9. Need Help?: Contact information for FrontCounter BC

### 5. Troubleshooting

If you selected I am a Business from the NR Online Services Sign Up page, but try to log in with a Personal BCeID, you will be prompted to sign in with a

Business BCeID or sign up as an

Individual.

The following are some error messages that may appear during sign up to NR Online Services.

If you have already signed up for NR Online Services and try to sign up again, you will be shown a message that you are already signed up.

Click **OK**, and you will be taken to your dashboard.

You tried to sign up but you already have an account with Natural Resource Online Services. Click OK to view your Dashboard.





If BC Registries was unavailable during sign up, NR Online Services will use your BCeID information to create your account. The following message will display.

Click **OK** to proceed to your dashboard.



You cannot use a Basic BCeID account to sign into NR Online Services. If you attempt to sign in with a Basic, you will be shown this error message.

Click **Return to Log In** to sign up with a business or personal BCeID.

### 6. Glossary

- BCelD
  - An online account that provides secure electronic access to participating online government services. A BCeID consists of creating a username and password and allows you to save your application, reopen it and check the status of your application online.
- Client
  - An individual, business or organization that is doing natural resource business through NR Online Services.
- Registration
  - Refers to a client registering for a BCeID account.
- Natural Resource Online Services (NR Online Services)
  - A portal that allows clients to access natural resource sector data, business forms and applications for multiple business areas.
- Client Representative
  - o Individuals given permission to act on behalf of a client in NR Online Services.
- Sign Up
  - Refers to the process a client goes through to sign up with NR Online Services.
- Smartform
  - Online forms a client or their representative must complete to submit an application for a natural resource activity.
