AMENDMENT NUMBER 52

Whereas the lands described hereinafter are within Tree Farm Licence Number 1 and are found to be suitable for a higher economic use than the growing of forest crops;

And whereas the Licensee has requested the withdrawal of those parts of the aforementioned lands from within Schedule "A" of the said Tree Farm Licence;


And whereas the withdrawal of the aforementioned lands will not effect the sustained yield management of the said Tree Farm Licence;

Therefore pursuant to subsection (14) of Section 36 of the Forest Act being Chapter 153 of the Revised Statutes of British Columbia, 1960 and pursuant to Clauses 11 and 13 of the said Tree Farm Licence the following lands are hereby withdrawn from the lands described in Schedules "A" and "B" of the said Tree Farm Licence and more particularly described as follows:
