

IN THE MATTER OF SECTION 33 OF THE MINERAL TENURE ACT R.S.B.C. 1996, CHAP 292

AND

ORDER OF THE CHIEF GOLD COMMISSIONER

WHEREAS, Kingfisher Resources Ltd, the recorded holder of mineral claims title number 1061192, 1061193, 1061194, 1061195, 1061196, 1063430, 1063804, 1065561, 1065567, 1065568, 1065569, 1065570, 1065571, 1065572, 1065573, 1065574, 1065575, 1065576, 1065583, 1069361, 1069363, 1070111, 1070867, 1070868, 1071829, 1071830, 1072798, 1072799, 1081199, 1081200, 1081201registered technical exploration and development work pursuant to the mineral claims under Section 29 of the *Mineral Tenure Act* (the Act);

AND WHEREAS, Section 33(1) of the Act requires the recorded holder to submit a report in the form and manner prescribed by the Mineral Tenure Act Regulation (the Regulation) respecting this technical exploration and development;

- I, Donna Myketa, Chief Gold Commissioner for the Province of British Columbia, order the reduction of the work credits recorded on event 5924016 based on the following:
 - Section 16(3) of the Regulation requires that the report must be in the form and medium specified in Schedule A of the Regulation.
 - Section 16(5) of the Regulation states that if the recorded holder fails to submit a report, as required under section 16(3) of the Regulation, the Chief Gold Commissioner may notify the recorded holder of the intention to cancel the registration of the recording of exploration and development under Section 33 of the Act.

- On February 08, 2022, exploration and development work was registered and recorded as per Mineral Titles Online event number 5924016.
- On May 06, 2022, a technical report was submitted under Mineral Titles Online event number 5924016 for the total applied work value of \$422,620.83.
- On August 23, 2023, you were advised by letter or email of an intention to reduce the registration of the recording of the exploration and development work that the submitted report for event 5924016 was approved at a value of \$220,229.33 instead of \$422,620.83.
- For these reasons, the value of work applied to mineral claims 1061192, 1061193, 1061194, 1061195, 1061196, 1063430, 1063804, 1065561, 1065567, 1065568, 1065569, 1065570, 1065571, 1065572, 1065573, 1065574, 1065575, 1065576, 1065583, 1069361, 1069363, 1070111, 1070867, 1070868, 1071829, 1071830, 1072798, 1072799, 1081199, 1081200, 1081201 is reduced by \$108,565.54 to align the good to dates of all claims.
