Policy Rationale & Purpose:

The purpose of this policy is to set the requirements for reapplying for licensure when an EMA's licence has been revoked by the Board as a result of the EMA having breached a term or condition of their EMA Licence in regard to failing to meet their continuing competence requirements.

Policy Scope:

This policy applies to all former British Columbia (BC) EMAs that were previously licensed in the Emergency Medical Responder, Primary Care Paramedic, Infant Transport Team, Advanced Care Paramedic, or Critical Care Paramedic categories in BC, whose licence was revoked by the Board for having breached a term or condition of their licence by failing to meet their continuing competence requirements.

Policy Statement:

A former EMA whose licence was revoked by the Board for having <u>breached a term or condition of</u> <u>their licence by failing to meet their continuing competence requirements</u> may reinstate their licence for up to <u>three years</u> from licence revocation, by successfully completing the practical (Oral exam for CCP), written and jurisprudence examinations for the licence category and may be subject to additional requirements as determined by the Board. Please see the <u>Scheduling your Licensing</u> <u>Examinations</u> page on the Board's website for instructions on how to schedule examinations. If it has been greater than three years since the former EMA's licence revocation, their file must be evaluated by the Board to determine licensing requirements. Requests for reinstatement can be emailed to: <u>getanexam@gov.bc.ca</u>.
