THIS AGREEMENT is dated the 12 day of August

BETWEEN:

THE MINISTER OF FORESTS, on behalf of HER MAJESTY THE QUEEN IN RIGHT OF THE PROVINCE OF BRITISH COLUMBIA, Parliament Buildings, Victoria, British Columbia, V8V 1X4.

(the "Licensor")

AND:

POPE & TALBOT LTD. P.O. Box 39 **Grand Forks**, British Columbia **V0H 1H0**

(the "Licensee")

WHEREAS the land described hereinafter lies within Tree Farm Licence (TFL) No. 8 is to be transferred to the adjacent Crown land portion of Woodlot Licence No. 470, and to be transferred to the adjacent Boundary Timber Supply Area;

AND WHEREAS the Chief Forester has determined that the portion of the AAC attributable to the land is 280 m^3 , and does not exceed 7,250 m^3 ;

THEREFORE the parties agree to amend TFL No. 8 as follows:

ARTICLE I

Pursuant to Section 39(1)(e) of the *Forest Act* and Paragraph 1.12 of TFL No. 8:

Amendment of Schedule "B" Land

- 1. delete 163 hectares, more or less, from Schedule "B" lands of TFL No. 8;
- 2. 147 hectares, more or less, of the said land will be added to Schedule "B" lands of Woodlot Licence Number 470 (W0470) more particularly shown outlined in bold black on the attached Exhibit "A", dated March 27, 1998;
- 3. the remaining 16 hectares of Crown land is to be transferred to the Boundary Timber Supply Area, more particularly shown in hatched lines on the attached Exhibit "A", dated March 27, 1998.

ARTICLE II

The volume of timber for non-replaceable timber sale licences specified in Subparagraph 1.07(a) of TFL No. 8 is hereby reduced by 280 m^3 ; and the new volume of timber for timber sale licences is 6 970 m³ per year.

ARTICLE III

Upon expiry of W0470, the said lands so withdrawn shall no longer be subject to or form any part of the said tree farm licence area.


