# **Beverage Container Stewardship Program Regulation Annual Report by the Director**

2003-04 Reporting Period

### **Synopsis**

The regulation encompasses all containers of ready-to-drink beverages, except for milk, milk substitutes, infant formula and meal replacements. The regulation requires a seller of beverages to collect a deposit from the purchaser, specifies the minimum amount of the deposit and requires sellers and/or depots to accept containers and pay a refund per container not less than the amount of the deposit collected. Containers are managed in accordance with three stewardship plans approved under the regulation. The stewardship plans are required to show how an 85% recovery rate will be achieved within 2 years after the implementation date for the plan.

In 2003-04, the overall recovery rate was 83.8 %, up marginally from 83.7% in 2002-03.

## **Program Performance**

#### **Stewardship Agencies**

The three stewardship agencies established by the beverage industry to meet their responsibilities under the regulation are:

**Encorp Pacific (Canada)** (Encorp) is responsible for non-alcoholic beverage containers, representing **56%** of total containers. Encorp's overall recovery rate increased by 1.4% compared to last year, with marginal to modest increases in the recovery rate for all categories but one. And in that one, with a volume that is statistically insignificant, the decrease could be the result of shipments recorded in the next time period.

**Liquor Distribution Branch** (LDB)is responsible for wine, spirit, non-refillable beer, cider and cooler containers, representing **9%** of total containers. LDB's overall recovery rate increased marginally by 0.2% compared to last year, with a slightly higher increase in the wine and spirit glass containers rate overcoming the slightly lower decrease in the rate for non-refillable beer, cider and cooler glass containers.

Brewers Distributors Ltd. (BDL)is responsible for refillable glass bottles and aluminum cans for beer, ciders and coolers, representing 35% of total containers. BDL's overall recovery rate decreased by 2% compared to 2002, with decreases in all categories, chiefly aluminum cans and non-industry standard refillable bottles. According to BDL, while the overall percentage of beer containers returned dropped, the total number of containers returned increased by over 6.8 million containers. The 2 percent drop is due to sales growth of 3.4% with container return growth of 1.3%. BC had a record year for beer sales growth in 2003/04 caused in part by the significant expansion of retail outlets (over 200). Because of inventory in these new stores and the lag time from when a product is sold until the time a consumer returns the container, which can extend over several months, high sales growth can give the appearance of a drop in returns. Over time as this lag works its way through the system this differential will be eliminated.

#### **Overall Financial Information and Recovery Rate**

Funding for the management of containers is generated through unredeemed deposits, revenue from sales of recyclable material and for some containers, brand-owner eco-fees. The following independently audited financial and recovery rate information has been provided by the industry stewards:

#### Brewers Distributors Ltd.

The vast majority of bottles are refilled an average of 15 times each. The small percentage of these bottles that are unsuitable for refilling are culled and sent to a processing facility for crushing and subsequent use in the manufacture of new bottles and various other uses.

Aluminum cans are crushed into biscuits and shipped to an aluminium recycler for production of new aluminum cans and other fabricated aluminum products.

#### Associated Agencies

#### The Beverage Container Management Board (BCMB)

The BCMB meets at least on a quarterly basis or more often as needed, and provides advice to the Minister on the deposit-refund system in particular and beverage container program issues in general. The ten member board comprises representatives nominated by the three industry stewards, the BC Bottle Depot Association, Union of BC Municipalities, labour, retail grocers, Recycling Council of BC, an environmental non-government organization and the Ministry of Water, Land and Air Protection. The Board is chaired by John Nixon, representing Encorp Pacific (Canada).

#### Recycling Council of BC (RCBC)

RCBC provides information to callers to its Recycling Hotline on a number of stewardship issues, under contract to various stewards.
