WHEREAS:

- A. The Licensee is the holder of Tree Farm Licence 54, dated June 1, 2012.
- B. The Licensee has provided consent on July 26, 2017, to amend Tree Farm Licence 54 in accordance with section 39.1 of the *Forest Act*, by removing 1.37 ha of crown land from Schedule B Lands of Tree Farm Licence 54.
- C. The Minister considers that forest management would not be compromised by the actions described in B.

TFL 54 Instrument 7

THEREFORE:

- 1. In accordance with Section 39.1 of the *Forest Act*, the Minister and the Licensee agree that Tree Farm Licence 54 is amended, as of the effective date of this instrument, by deleting all Schedule B Lands described on the attached map labeled TFL 54 Instrument 7 *Forest Act*, Section 39.1 Deletion.
- 2. For the purpose of Section 8 of the Allowable Annual Cut Administration Regulation, the allowable annual cut of the area deleted under 1 above is 0 m³/year.
