INCREMENTAL TREATY AGREEMENT AMENDING AGREEMENT

BETWEEN:				

Her Majesty the Queen in right of the Province of British Columbia, as represented by the Minister of Aboriginal Relations and Reconciliation

(the "Province")

AND:

Pacheedaht First Nation, on behalf of itself and its Members, as represented by their Chief and Council

("Pacheedaht First Nation")

(Collectively referred to as the "Parties" and individually referred to as a "Party")

WHEREAS:

- A. The Parties entered into an Incremental Treaty Agreement dated March 26, 2013 under which District Lot 247 Block A, District Lot 247 Block B, District Lot 251 and District Lot 252 (the "Lands") are to be transferred by the Province to Pacheedaht First Nation prior to the Effective Date of the Pacheedaht Final Agreement;
- B. Article 5 of the Incremental Treaty Agreement sets out the timeframes for the Lands to be transferred;
- C. The Parties wish to change the timeframe for transferring District Lot 247 Block A and District Lot 252 under the Incremental Treaty Agreement;
- D. Section 11.11 of the Incremental Treaty Agreement provides that it may be amended from time to time by the Parties by an instrument in writing.

NOW THEREFORE the Parties agree as follows:

ARTICLE 1: INTERPRETATION

- 1.1 **Definitions**. In this Amending Agreement and the Recitals to this Amending Agreement:
 - "AIP Date" means the date on which the authorized signatories for the Parties and Canada initial the Agreement in Principle, as described and defined in the ITA;
 - "Amending Agreement" means this Incremental Treaty Agreement Amending Agreement;

"Final Agreement" means the Pacheedaht First Nation Final Agreement to be concluded by Canada, the Province and the Pacheedaht First Nation at the conclusion of Stage 5 of the British Columbia Treaty Commission Process;

"Final Agreement Signing Date" means the date on which the authorized signatories for the Parties and Canada sign the Final Agreement, as described and defined in the ITA;

"ITA" means the Incremental Treaty Agreement, dated for reference March 26, 2013, entered into by the Province and Pacheedaht First Nation;

"ITA Date" means the date on which the ITA is executed and delivers by the Parties, as described and defined in the ITA;

"Permitted Encumbrances" means the reservations, exceptions, liens, charges, and interests as described in Part 2 of Schedule 1 of the ITA, as described and defined in the ITA.

ARTICLE 2: TRANSFER

Transfers of District Lot 247 Block A and District Lot 252. In accordance with Article 11.11 of 2.1 the ITA, the Parties hereby amend Section 5.1(a) and Section 5.1(c) of the ITA to change the timeframe for transferring District Lot 247 Block A from "as soon as practicable after the Final Agreement Signing Date" to "as soon as practicable after the AIP Date" and District Lot 252 from "as soon as practicable after the ITA Date" to "as soon as practicable after the Final Agreement Signing Date." In all other respects, the ITA remains unaltered, and unless provided otherwise, its provisions are applicable in respect of this Amending Agreement.

ARTICLE 3: COMING INTO EFFECT

3.1 Commencement . This Amending Agreen	nent comes into effect on the date first written above.
