Re: New Initiatives to Support the Harvest of Residual Fibre in Conjunction with Traditional Primary Harvesting (integrated harvesting)

The purpose of this memo is to advise you of two new initiatives that support the provincial objective of increasing the use of residual fibre through encouraging integrated harvesting methods and ensuring all appropriate crown revenue control requirements are being met. The Forestry Fibre Action Plan was prepared in response to Minister Thomson's mandate to "examine ways to enhance the security of fibre supply for secondary and non-lumber users of lower quality and residual fibre."

The two initiatives are:

- 1) Pre-Harvest Waste Assessment (PHWA) process; and
- 2) Biomass Handling Guidelines.

Pre-Harvest Waste Assessment

In support of enhancing fibre supply for Secondary Manufacturing Facilities, Timber Pricing Branch (TPB) has developed a PHWA process which will allow timber to be transported for the purpose of manufacturing it into Special Forest Products (SFP) at the same time that primary harvesting operations are being conducted.

Following significant review of pilot projects in the southern interior, amendments have been made to the *Interior Appraisal Manual* and the *Provincial Logging Residue and Waste Measurement Procedures Manual* that provide for waste assessments being completed prior to harvesting a block.

I expect that all district managers will remain as signing authority for the PHWA SFP authorization (as attached) under s.94.1 of the *Forest Act* and carry out their role as outlined in the SFP authorization. Licensees must follow the authorization conditions as listed. TPB will be implementing communication and training plans on this initiative in the near future.

<u>The PHWA has three main components</u>: 1) Approval of a waste assessment, 2) Approval of a SFP Authorization, and 3) Monitoring by Districts to ensure no SFP enters a sawmill.

Biomass Handling Guidelines

Both the PHWA and Biomass initiatives add to what has already been implemented under the Forestry Fibre Action Plan (fibre recovery process; waste benchmark policy etc.) to promote business to business relationships where there is supply and demand for residual forest fibre. The purpose of the Biomass operational guidelines is to provide advice on how to handle forestry biomass (where it has been determined that some or all of the biomass will be harvested) in a manner that promotes its harvest in the most efficient and cost-effective manner. The guidelines represent the best practices available to date and are available to be used voluntarily by primary harvesters and secondary users.

Finally, I wish to thank the Natural Resource District Managers and Timber Sales Managers for implementing the Forest Fibre Action Plan and their continued dialogue at the operational level with forest sector representatives on improving fibre utilization.
