Commencing at a point 1 500 m due east and 250 m, more or less, due north of the northeast corner of lot 7947, that point being on the natural boundary of the right bank of Halfway River, thence due south 500 m, thence N  $70^{\circ}$  E 1 100 m, thence due north 500 m, more or less, to the natural boundary of the right bank of Halfway River, thence southwesterly on that natural boundary to the point of commencement.
