OVERVIEW OF LGCAP YEAR 2 SURVEY RESULTS CLE'CAN BC

Action	Status
Climate action plans	97 communities (18% increase from first year of program)
Net-zero commitments	42 communities
Climate lens application	25 communities
Community-wide GHG emissions	8 communities (69% decrease from 2021)
Corporate emissions reporting	104 communities (100% increase from 2021)
Risk and vulnerability assessments	79 communities (30% increase from 2021)

LGCAP YEAR 2: WHAT WORKED WELL





- Reporting (May-July): only 7 of 197 participants missed the 1st funding disbursement
- Support: responsiveness to inquiries & guidance
- Pre-launch communications
- Survey changes and enhanced analysis
- Corporate emissions measurement quantification tools and support
- All communities in B.C. are now signatories to the Climate Action Charter
- Integration into the Climate Change Accountability Report

LGCAP YEAR 2: OPPORTUNITIES FOR IMPROVEMENT



- Webpage structure and too many resources
- Survey user testing, feedback and SimpleSurvey functions
- More clarity needed on:
 - Required vs. optional survey questions
 - Scope for investment questions
 - Number of climate staff further scope definition
 - Carbon neutrality <u>not</u> being a component of the program
 - How to satisfy the public posting requirement
 - What's in scope vs. out of scope for emissions reporting

LGCAP YEAR 3: WHAT WE'RE DOING



- Webpage/communications improvements
- Updating and consolidating program resources
- Requesting SimpleSurvey improved functionality
- Seeking more survey user testing and feedback
- Improving clarity of survey questions and examples
- Developing guidance on how to spend funds
- Revising corporate inventory reporting requirements
- Reconsidering funding direction
- Regional approaches to climate action
