

APPLICATION AND AMENDING AGREEMENT FOR ADDING A SPOUSE TO A PROPERTY TAX DEFERMENT AGREEMENT

under the Land Tax Deferment Act

GENERAL INFORMATION

This application package is for home owners with a tax deferment agreement who wish to add their spouse to title and continue deferring their property taxes.

Note: A spouse is defined as a person who is married to another person or is living with another person in a marriage-like relationship for a continuous period of least two years.

If you are a home owner with a tax deferment agreement, you may be able to add your spouse to the title of your home as a tenant in common, or joint tenant, without having to first repay your tax deferment loan. The portion of your interest in the home that is being transferred must be less than 100%.

Note: If you intend to remove yourself entirely from the title of your home, you will have to repay your tax deferment loan. Contact our office for a payout amount.

To add your spouse to the tax deferment agreement, complete an Application for Adding a Spouse to a Property Tax Deferment Agreement (Form 1A on page 2). You and your spouse, along with any other person who is on title as an owner of your home, will also need to sign the Amending Agreement (Form 4 on page 3).

Both of the original forms need to be sent to the mailing address below after they have been completed and signed. If your application is approved, we will return the Amending Agreement to you (or your lawyer or notary, if applicable) with a letter consenting to the transfer of a portion of your interest in the home to your spouse. The Amending Agreement and the consent letter need to be filed at the land title office (or Manufactured Home Registry office if you have a manufactured home) with the appropriate property transfer forms.

When your spouse is added to the tax deferment agreement, you will become jointly responsible for all property taxes, interest charges and administration fees deferred under it. This includes any taxes, interest and fees deferred before your spouse was added to the title of the home.

It is important that your spouse understands the debt they are taking on by being added to the tax deferment agreement. They should review the latest statement of account, which is sent out each spring showing the balance owing as of March 31, as well as your copy of the tax deferment agreement. If you would like to know the current balance of your account, call our office.

INSTRUCTIONS – READ BEFORE COMPLETING FORM 1A

Complete this form if you:

- (a) are an owner of property who is currently deferring taxes under a property tax deferment agreement made under the Land Tax Deferment Act, and
- (b) wish to apply for an amending agreement to add your spouse to the agreement.

OWNER'S INFORMATION

Enter your name, mailing address and contact telephone number.

SPOUSE'S INFORMATION

Enter your spouse's name, mailing address and contact telephone number (if different from your mailing address and contact telephone number).

LAWYER'S / NOTARY'S INFORMATION

If you prefer that we send the consent letter and approved Amending Agreement directly to your lawyer or notary, enter their name and mailing address. Otherwise, leave blank.

PROPERTY INFORMATION

Enter the Parcel Identifier (PID) number or Manufactured Home Registration number (for manufactured homes) for your home, which may be found on your property tax deferment agreement approval letter and also on your property tax notice.

Note: Only one number can be entered online. If your home has more than one PID number, write in the additional number(s) after you have printed the form.

TAX DEFERMENT INFORMATION

Enter the account number for your property tax deferment agreement, which may be found on your property tax deferment agreement approval letter and also on your annual statement of account (e.g. PTD-0000-0001).

OWNER'S DECLARATION

After you have printed off the completed form, sign and date the declaration, and complete **Form 4**.

INSTRUCTIONS – READ BEFORE COMPLETING FORM 4

Sign and date the form beside your name. Your spouse must sign and date the form beside his or her name.

OWNER'S NAME IN FULL (if more than one owner) This only needs to be completed if there is another person(s) on title as an owner of your home. Otherwise, leave blank. The other owner(s) must enter his or her name, and sign and date the form.

We, the undersigned owner/owners (the Owner) of the property identified in the application (the Property) and the undersigned spouse (the Spouse) of the/an Owner, acknowledge that:

- the Owner made an agreement (the Deferment Agreement) under the Land Tax Deferment Act (the Act), with His Majesty the King in right of British Columbia (the Province), as represented by the minister responsible for the administration of the Act, permitting the Owner to defer property taxes on the Property;
- the Deferment Agreement has been deposited at the Tax Deferment Office and bears Account Number ______, as assigned to it by the Province;
- the Spouse is married to the Owner, ______, or is and, for a continuous period of at least two years, has been living with that Owner in a marriage-like relationship;
- the Spouse has read both the entire Deferment Agreement and the most recent statement of account setting out the amount outstanding under it;
- we have requested the minister responsible for the administration of the Act to enter into this Amending Agreement and wish to amend the Deferment Agreement to add the Spouse as a party to it.

Therefore, we agree with the Province as follows:

- The Deferment Agreement is amended to add the Spouse as a signatory to it, by adding the name of the Spouse in one of the spaces provided for an owner's name.
- The Spouse agrees to be bound by and to perform, satisfy and discharge all of the obligations, liabilities and duties under the Deferment
 Agreement, as hereby amended, as if he/she were an original signatory to it. Without limiting the generality of the foregoing, the Spouse,
 together with the Owner, shall be liable for all taxes, interest, administration fees and charges that, at any time prior to the time at which
 this Amending Agreement takes effect, have been or may be deferred under the Deferment Agreement.
- This Amending Agreement shall be read together with the Deferment Agreement, and we confirm that, except as modified by this
 Amending Agreement, all covenants, terms and conditions in the Deferment Agreement shall remain unchanged, unmodified and in full
 force and effect.

We authorize the Province to:

- obtain the Parcel Identifier (PID) Number(s), registered owner information and legal description of the Property, or the details of the manufactured home that correspond with the Property and to endorse that information on this Amending Agreement with the intent that the endorsement will form part of this Amending Agreement, and, in the case of the manufactured home, endorse the information on the financing change statement;
- register this Amending Agreement as a modification to the registered charge created when the Deferment Agreement was registered in
 the land title office, or, in the case of a manufactured home, to register a financing change statement amending the financing statement
 registered at the Personal Property Registry when the Deferment Agreement was originally made.
