Amendment

THIS AGREEMENT is made effective the 13 day of 5ept, 2018.

BETWEEN:

AND:

WHEREAS:

- A. The Licensee is the holder of Tree Farm Licence 47, dated March 1, 2010.
- B. The current Schedule B of the TFL agreement states that "All Crown lands not otherwise alienated within the areas outlined in bold black on the accompanying

maps except Crown land reverted subsequent to 1971, which was subject to an old temporary tenure (within the meaning of the Forest Act assented to March 30, 1972) and held by a person other than the Licensee." are part of the TFL. As requested by the Licensee on June 22, 2017, this clause will be replaced by amending Tree Farm Licence 47 in accordance with section 39.1 of the *Forest Act*, by adding the entirety of TL's T0417, T0426 Blk 2 DL833, T0168 DL834, and T0995 and removing the entirety of T0185 DL778, T0426 Blk 1 DL653 and TL10839p from Tree Farm Licence 47.

- C. The Licencee will have no future claim on the TL's T0185 DL778, T0426 Blk 1 DL653and TL10839p that were not reverted into the TFL. No compensation will be provided for these areas.
- D. For the purpose of section 8 of the Allowable Annual Cut Administration Regulation the AAC of the area of land to be added will be zero
- E. The Minister considers that forest management would not be compromised by the actions described in B.

THEREFORE:

- The clause "All Crown lands not otherwise alienated within the areas outlined in bold black on the accompanying maps except Crown land reverted subsequent to 1971, which was subject to an old temporary tenure (within the meaning of the Forest Act assented to March 30, 1972) and held by a person other than the Licensee." on the top of page 50 of Schedule B of the TFL agreement is cancelled and will be removed when the current licence is replaced.
- 2. In accordance with Section 39.1 of the Forest Act, the Minister and the Licensee agree that Tree Farm Licence 47 is amended, as of the effective date of this instrument, by adding all of the Crown Lands described on the attached map labeled **TFL 47 Instrument 22, Forest Act, Section 39.1 Addition**
- 3. For the purpose of Section 8 of the Allowable Annual Cut Administration Regulation, the allowable annual cut of the area added under section 2 above is 0 m³/year.
