PART 1. Legislative Reporting Requirements

Declaration statement: This PSO Climate Change Accountability Report for the period January 1, 2022 to December 31, 2022 summarizes our greenhouse gas (GHG) emissions profile, the total offsets to reach net-zero emissions, the actions we have taken in 2022 to minimize our GHG emissions, and our plans to continue reducing emissions in 2023 and beyond.

Emission Reductions: Actions & Plans

A. Stationary Sources (e.g. buildings, power generation)

- 1) Actions taken to reduce emissions in 2022
 - a. Adjustment of lighting schedules to minimize run time of unused zones
 - b. Adjustments of HVAC schedules to minimize run time of unused zones
 - c. Optimization of building management systems
 - d. Calibration of energy metering systems
- 2) Plans to continue reducing emissions in 2023 and beyond
 - a. Continuous optimization of building management and lighting control systems
 - b. Reduction in decentralized electrical appliances

B. Mobile Sources (e.g. fleet vehicles, off-road/portable equipment)

- 1) Emily Carr University has access to electric vehicle charging stations in parkade for staff and students driving electric cars
- 2) Plans for the lifecycle replacement of the propane powered forklift with an electric model

C. Paper Consumption

- 1) Emily Carr University purchases office paper with 75% recycled content
- 2) University printers are set to print double sided where possible
- 3) Paper consumption is reduced through digital document storage and electronic filing
