2. Program Outline

Western Pacific Electrical Supplies Ltd. is open to the electrical trade and is the lower mainland's source for all electrical supplies.

Since our inception, we have designed our recycle program to achieve maximum awareness, participation and cost effectiveness.

3. Public Education Materials and Strategies

We recognize that to achieve our goal to educate people to recycle, we need to build awareness among consumers and simultaneously turn that awareness into action.

We also dedicate considerable time and effort to spread program awareness and activity at our collection facility at 13376 Comber Way, Surrey, B.C.

Consumer Awareness

Western Pacific Electrical Supplies Ltd. make consumers aware of the program through:

- advertisements in the local newspapers
- Display banners at the sales counter
- Adding the program information to our website www.westernpacificelectrical.com
- Consumer awareness through periodic seminars at our office.
- Distributing promotional items (brochures etc.)

4. Collection System and Facilities

Our principal collection method from consumers is our drop-off boxes at our location 13376 Comber Way, Surrey, B.C.

5. Product Environmental Impact Reduction, Reusability and Recyclability

Western pacific Electrical Supplies Ltd. seeks to achieve greater environmental sustainability through the reuse and recycling of lighting products. In addition to the activities outlined throughout this report, we are focused on continued sustainable development.

Management has put together two tier system to monitor and manage producer's effort. On front end, employees are trained to receive various lighting products that are brought in. These products are then checked to categorized as per pollution prevention hierarchy - reuse, recycle, recover, waste. A proper tracking system is maintained to record all these receivables.

After sorting, categorizing is completed, all products are then stored at a dedicated place in proper manner to minimize any damage. Product returns that are deemed to still have a useful life will be recorded by quantity and forwarded to not for profit organization at no charge accompanied by a no charge invoice and packing slips to confirm delivery. We already have an arrangement with Habitat for Humanity in place. Please see Appendix A. As and when the products are ready to transport either to reusable partner location or recycling/recovering location, date of transport is recorded. A dedicated body is overlooking all these efforts and making any necessary fine-tunes to overall workflow and monitoring process.

All the Western Pacific suppliers have been advised to reduce the usage of Styrofoam and use some alternate packaging material.

Lighting Fixture and Lamps for recycle

After determination of an item which does not qualify for reuse, product disassembly would begin between metal, glass and bulbs.

Through a third party recycler lighting products will be shipped by quantity and they would establish a recycle composition rate. The material after processing will be weighed again to determine the weight proportions of product created for remanufacturing and for disposal at the landfill.

Flouroscent bulbs

We have an agreement with the third party recycler who has special machines to process bulbs. These machines will capture phosphors and mercury in the bulbs. They will handle the hazardous material in accordance with Ministry of Environment.

APPENDIX A

SAFE USE AND STORAGE OF PRODUCTS

LIGHT BULBS

- Handle all light bulbs carefully when installing and removing them
- Avoid touching the glass to prevent oils from your fingers from leaving residue on the glass
- If you break a CFL or any other type of lamp take precautions when cleaning it up.
 - o Remove people and pets
 - o Avoid stepping on the broken glass
 - o Ventilate the room if you have broken a CFL and open any windows. This will reduce any possible mercury vapor
 - o Wear gloves to avoid contact with mercury or broken glass
 - o Scoop or sweep up broken debris onto a piece of still paper
 - o Use sticky tape to pick up any remaining glass or powder
 - o Wipe the area clean with a disposable wet cloth
 - o If it was broken on a rug, take it outside and shake out all debris
 - o If it is not removable, vacuum the carpet
 - o Place in a cardboard box with all sides taped shut. Do not throw in the garbage
 - o Wash your hands after cleaning
- When changing lamps, consider using a dropcloth to minimize the risk of breakage should the lamp fall
- Store lamps in original containers to prevent breakage
- Do not throw light bulbs in the garbage or curbside recycling. Return them to participating recycling depots for recycling

LIGHTING FIXTURES

- Lighting fixtures should be installed by a qualified professional to local electrical codes
- Follow the lighting fixtures installation instructions and safety warnings when installing the fixture
- Fixtures should be stored in their original packaging to avoid damage before installing
- Lighting fixtures should not be placed in the garbage or curbside recycling. They should be returned to participating recycling centers for recycling.

Boy's rare skin disease spurs charity

SURREY — If you've ever accidentally burned yourself on the stove to the point where you thought you might pass out from the pain, then you have some inkling of what an 11-year-old Surrey boy deals with on a daily basis.

Brayden Mann has an extremely rare genetic condition called Epidermolysis Bullosa (EB), affecting one in 50,000 births. The skin disease results in painful blisters, open wounds and shearing of the skin from even the most gentle of touches. EB sufferers have been called "Butterfly Children," as their skin is as fragile as a butterfly's wing.

The feeling has been compared to having second- and third-degree

burns on the body.

"He'll wake up with skin missing, just the way he rubbed while moving in bed," says Deep Mann, Brayden's mom.

Because the condition is so rare, diagnosing it was difficult. A pediatrician once told her not to worry, that it's not painful and he would grow out of it. Not only was the doctor wrong, the disease is so painful that Brayden takes Tylenol and Advil for pain management. Some children with EB are prescribed morphine, something Deep wants to avoid. In the more severe versions of EB, the hands and feet become webbed and the children are bound in wheelchairs.

But perhaps the most painful part of the disease comes in the form of reaction from other people. "The biggest reason why we want

people to be aware is a lot of kids stare," said Mann, her voice cracking.

Brayden was teased by another child in his school to the point where he told his mother he didn't want to live anymore. He was eight years old at the time. Expressions of suicidal thoughts led the family to follow up with an "awareness session" at his school,

Boundary Park Elementary to teach students about condition.

"He became a celebr after that," recalls Mann laughing. "All of the kids wanted to meet him, w was kind of cute."

On Oct. 24, local res hosted a fundraising event at Morgan's Pub House in Surrey, raisir \$3,500 for DEBRA Ca (Debracanada.org), a profit that helps supp families with EB.

The charity is also requesting the commu support to jumpstart a media campaign called #EBBalloonPop. Expla Mann, "as part of daily wound care, EB patien often need to pop the blisters. In order to rais awareness, we are aski community to have fu creative and pop a ball support of EB."

Mayor Lois Jackson, who was acclaimed for a sixth term after no challengers came forward, said she was pleased there wasn't a significant drop off in voter turnout given there was no mayor's race.

Voter turnout was 32.11 per cent, slightly below the 33.5 per cent in 2011.

She said they really pushed hard to get the vote out.

SCHOOL BOARD RESULTS

Incumbents also did well in the race for the Delta school board's seven seats. Five of the six sitting trustees — Laura Dixon, Nick Kanakos, Val Windsor, Dale Saip and Fabian Milat — were re-elected. They have been joined by a pair of newcomers, Bruce Reid and Rhainnon Bennett, both members of the Kids Matter slate.

Incumbent Donna Burke was defeated.

Dixon, who was board chair in the previous term, had endorsed Burke during the campaign and was sorry to see she did not get re-elected.

"Donna's loss will be keenly felt," Dixon said. "I'm really sad that she wasn't successful tonight."

Reid and Bennett both received the endorsement of the Delta Teachers' Association.

Dixon said while both have backgrounds in education and working with youth, the new trustees will have a steep learning curve in the beginning.

"I want to congratulate all the candidates who put their names forward," she said.

Nic Slater, the third member of the Kids Matter slate, finished eighth, narrowly missing a seat on the board.

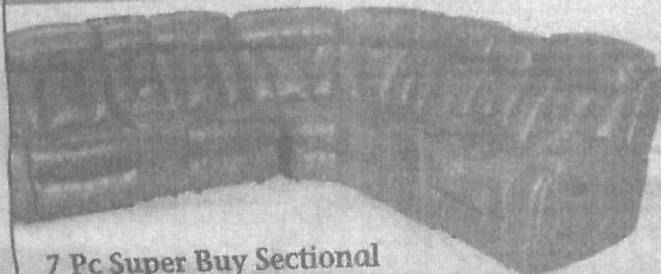

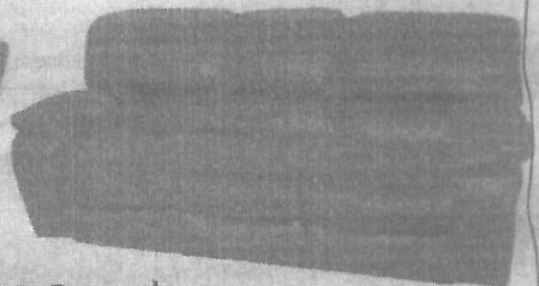

night.

"They're from all over Surrey, these youth," Surrey RCMP Sgt. Drew Grainger said at the time. "This confrontation quickly escalated violently and was fueled by a toxic mix of alcohol, testosterone and poor judgment."

Some young men, most of them 18 or 19 years old, were milling around in the back parking lot when a minivan drove up and all hell broke loose. The minivan's windows were smashed in. Grainger said someone loosed a cloud of bear spray after the driver, a 22-year-old Surrey man, got out of his vehicle.

Dario told the jury he had acted in self-defence after one of the party bus riders slashed his chest and others trashed his van. The jury heard he whacked three victims on the head with a two-by-four and threw a rock at a fourth person.

Sayson argued that Dario had acted out of anger and vengeance, responding with disproportionate force on people who had nothing to do with the slashing or vandalism.

Dario's sentencing hearing is set for March 5.

Surrey school district's graduation rates up across board

SURREY — The number of students graduating from Surrey high schools went up in the most recent school year, with 88.8 per cent of

all students completing their education.

The number is up 2.7 per cent from the previous year and continues a trend that's

seen Surrey graduation rates steadily rise since 2009.

At that time, the rate was 82.1 per cent.

Female students had a

higher graduation rate than their male counterparts at 91.4 per cent compared to 86.4 per cent, both numbers were also up compared to

previous years. According to the district, this is the first time the female graduation rate has broken into the 90s. Aboriginal students saw a

significant rise as well, with 61 per cent graduating in the most recent school year compared to 48.2 per cent the year prior.

English language learner students also saw an increase of 2.6 per cent over the previous year with 92.6 per cent for 2013/2014 and special needs students also saw a slight bump from 59.2 per cent to 60.2 per cent.

"A second successive year of significant improvements in our six-year completion rate for all students is a testament to all the hard work put in by students and staff in Surrey Schools," said Shawn Wilson, Surrey Board of Education chair in a statement.

"The board is pleased to see improvement in the graduation results for aboriginal students and hopes to see that continue as there is still a long way to go."

Surrey's rates are higher than nearly all of the provincial graduation rates, save for aboriginal and special needs.

While the province's aboriginal graduation rate is just .6 per cent higher than the district's, the special needs rate is 1.6 per cent higher. For all other categories, Surrey outpaces the province by at least four points.

3 Surrey First sweeps election

It was an epic battle to replace outgoing mayor Dianne Watts in November's civic election.

Barinder Rasode, councillor at the time, split from Surrey First in April, citing hostility from her teammates as her reason for doing so. After much speculation in the media, she announced she would be seeking the mayor's chair.

Meanwhile, former mayor Doug McCallum came out of the woodwork to fight to regain his spot at the top. Then-councillor Linda Hepner, who received Watts' endorsement as her replacement, rounded out the "big three" contenders for the job.

Hepner described the election race as "engaged," with more community interest than the previous two, but added, "this one has been more destructive than I have seen in the past."

Crime and public safety, above all, dominated the race. All three contenders came out with crime platforms, and took jobs at one another over their public safety records.

At the end of it all, the torch was passed from Watts to Hepner, who won with 50,782 votes, roughly half of the total tally. The first-time mayoral candidate earned close to double the number of votes of her nearest rival, McCallum. But Hepner

didn't win on her own — her full Surrey First team was also victorious.

New councillors were Dave Woods, Vera LeFranc and Mike Starchuk. This was the second election in a row that saw Surrey First take every seat on council.

Hepner promises to continue Watts' legacy, have operational light rail in Surrey by 2018 and asked for 100 new police officers, which she promised on the campaign. Some have taken issue with planned tax hikes for 2015, which were revealed in mid-December and weren't mentioned during the election.

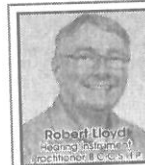
Surrey tax bills are set to rise by \$162 in 2015 as Surrey grapples with how to pay for the new officers.

Notably, the city is planning to introduce a \$100 cultural and recreational parcel tax to pay for capital projects on the books in order to free up money for the new cops.


