**WHEREAS:**

- A. The Licensee holds Tree Farm Licence 35, dated March 1, 2000.
- B. The Licensee has requested the Minister, under Section 39(3)(b) of the *Forest Act*, to amend Tree Farm Licence 35 by deleting the land added to Tree Farm Licence 35 through Instrument Number 11 on December 28, 2005 (Inkaneep Block), and to enter into a new Tree Farm Licence with the Licensee covering that same land.
- C. In accordance with Section 39 of the *Forest Act*, the Minister must carry out the request made by the Licensee under B, unless the Minister considers that forest management would be compromised.
- D. The Minister considers that forest management would not be compromised by the actions described in B.

**THEREFORE:**

In accordance with Section 39(3)(b) of the *Forest Act*, the Minister and the Licensee agree to amend TFL 35 by deleting the land added to Tree Farm Licence 35 through Instrument Number 11 on December 28, 2005, and

Section 1.09 (a) of the TFL 35 document is amended as follows:

*(a) subject to paragraph 1.17, 0 m<sup>3</sup> of the allowable annual cut, under non-replaceable timber sale licences; and*


