2015 Carbon Neutral Action Report School District No 75 (Mission)

This 2015 Carbon Neutral Action Report for the period January 1st, 2015 to December 31st, 2015 summarizes our emissions profile, the total offsets to reach net-zero emissions, the actions we have taken in 2015 to reduce our greenhouse gas emissions and our plans to continue reducing emissions in 2016 and beyond.

By June 30, 2016, School District No 75's final Carbon Neutral Action Report will be posted to our website at www.mpsd.ca.

School District No 75 promotes GHG emission reductions and environmental sustainability through both specific initiatives and guiding policies and procedures. The district's *Environmental Sustainability* policy promotes learning and leadership opportunities related to sustainability, energy and resource conservation, support for continuous monitoring of key environmental metrics, and support for environmental stewardship for both students and staff. The district also has an administrative procedure which established baseline energy consumption metrics, and stipulates the establishment of quarterly energy metrics, an annual review of targets, a target of 5% annual reduction of energy consumption, and remaining compliant with District of Mission GHG emission reduction targets (20% reduction between 2008 and 2020). While these policies, procedures, and goals remain in place, the loss of senior district positions in this area, including a dedicated Energy Manager, along with other funding constraints, has had a significant impact on the ability of the district to continue with the monitoring, reporting, and implementation of initiatives necessary to meet district goals.

Despite fiscal pressures, there were several initiatives taken in 2015 to reduce GHG emissions, including:

- High efficiency boiler plant installed at Mission Secondary School.
- Air handling unit and controls upgrades at Fraserview Learning Centre.
- Wattage reduction continues across all district facilities, helping to reduce annual kilowatt hours of electrical energy.

Going forward into 2016 and beyond, there are plans for further reduction of GHG emissions, including:

- New high efficiency boiler plants at Hatzic Middle School, Heritage Park Middle School, and Silverdale Elementary
- > HVAC system upgrades at Hatzic Middle School and Heritage Park Middle School

All proposed initiatives are contingent upon adequate capital funding.


