AMENDMENT NO. 35

This Indenture made in duplicate this //
day of JULY in the year of Our Lord One Thousand Nine
Hundred and Sixty-One.

BETWEEN:

THE MINISTER OF LANDS AND FORESTS
of the Province of British Columbia,
who, with his successors in office is

hereinafter called "the Licensor" of the one part,

AND

CELGAR LIMITED, a corporation duly
incorporated under the laws of the
Province of British Columbia, and
having its registered office in the
City of Vancouver in the said Province,

hereinafter called "the Licensee" of the other part.

WHEREAS by an Indenture made in duplicate on the 20th day of
July in the year of Our Lord One Thousand Nine Hundred and Fifty-Five
between the parties hereto, known and referred to as the Arrow Lakes
Tree Farm Licence and being numbered twenty-three (23) on the Forest
Service register of Tree Farm Licences, the Licensor did grant unto
the Licensee the management of certain Crown lands therein described
subject to the terms and conditions set forth in the said Indenture:

AND WHEREAS the parties hereto have mutually agreed to amend
the said agreement as hereinafter set forth.

NOW THEREFORE THIS INDENTURE WITNESSETH THAT in consideration
of the premises and the sum of One Dollar (\$1.00) of lawful money of
Canada now paid by the Licensee to the Licensor, receipt whereof is
hereby acknowledged, the parties hereto agree as follows:

- (1) That Schedule "B" of the said Indenture dated the 20th day
of July 1955 is hereby amended to include the lands formerly covered
by the timber sales listed below, and the lands described henceforth
shall be and are a part of the said Schedule "B".
